

Statement from Tsuchiyama - Nomination to the Board of Acupuncture

Acupuncture is the central component of a body of Oriental medicine that has been practiced throughout China, Korea, Japan and other parts of Asia for some 3000 years. It is a vast storehouse of knowledge, based on empirical observation, passed down from master to student over the centuries. To be a competent acupuncturist requires learning specific diagnostic techniques and the correct application of needling and other therapies under trained supervision. At a minimum, in the state of Hawaii, it requires 3200 hours of classroom instruction, 670 hours of supervised clinic practice. It is not a medicine that can be learned long distance, in a few dozen hours off a DVD course.

For years, in the US, acupuncture was treated with skepticism by the western medical establishment. The skepticism was probably a result of the fact that the exact mechanism of acupuncture's action has yet to be definitively shown (theories currently being explored include the endorphin hypothesis, neurogate theory, adrenal activation and release of endogenous corticosteroids). Of course the mechanism of action of many western therapies are not fully understood. Perhaps most famously, aspirin was used for some 80 years before its mechanism of action was finally demonstrated. Another cause of skepticism may be the language of oriental medicine which is rich with metaphor and allegory. It refers to different kinds of "Qi", yin and yang, and other terminology that requires comprehension and long study of a culturally distinct system.

These cultural barriers have taken a long time to overcome. But empirical proof of the efficacy of acupuncture has been impossible to ignore and today the World Health Organization and US Centers for Disease Control both recognize the efficacy of acupuncture in the treatment of a wide variety of health conditions. Acupuncture has now proven to be an invaluable adjunct and complement to western medicine, which is why all of the top hospitals in the USA now have acupuncturists on staff. I wholeheartedly believe in the complementarity of the two medicines.

I believe the role and responsibility of the Board of Acupuncture is to protect the integrity of this vast body of knowledge, to ensure that its practitioners in the state of Hawaii are required to meet a demanding standard of training and maintain the highest standards of ethical and professional conduct and that, in so doing, the interests of patients, consumers and the public at large are fully protected.

I work three days a week at the Queens Cancer Center and the Queens Women's Center, as well as maintaining a private practice. Prior to working in Hawaii, I worked in various hospitals in New York including New York Hospital and Lutheran Hospital. Moreover I was certified in acupuncture treatment of cancer patients by Memorial Sloan Kettering, one of the premier medical cancer institutions in the world. I believe this experience will be extremely useful in the ongoing discussions about the evolving relationship between these western and eastern medicine.

Prior to entering oriental medicine I was a successful businesswoman: I was a Vice President of Marketing for Calvin Klein, a Creative Director for Lifetime Television and owned two successful businesses. I have strong communication skills and have volunteered to testify on behalf of the Board of Acupuncture, should the need arise. I am familiar with the legislative process, have negotiated large contracts and am comfortable with reading legal documents.

I believe this background gives me the breadth of experience, the professional acumen and the executive tools to fulfill the demands of this board position.
