- (1) I believe in helping people straighten out their troubled life. As a member of the present State Correction Board, there is a wide range of troubled adults in prison. As a union official I see this situation in organized labor, (Printing Industry). Newspaper and Commercial Printing.
- (2) I have helped employees in the Printing industry to earn a decent paying occupation plus a pension to retire on. In the printing industry there are different classifications, General Worker, Apprentice Bindery, apprentice electronic Imaging, and apprentice Pressman. After serving their apprentice they then become a journeyman which is the top of the scale.

Besides wages, other benefits include Vacations, Sick leave, Severance pay, Holidays, Death in the family, Bension plan, Medical plan, Drug Plan, Dental plan, Group Life Insurance, Maternity leave.

There are employees that had a former prison background.

I have served with Boards and Commissions under two(2) Mayors, and four (4) Governors.

As Chairman, my biggest accomplishment in Honolulu on the Civil Service Commission was when three (3) police captains appealed as there was only one (1) police major on Oahu. After hearing their appeals, and as chairman of the Commission, I signed the order where today there are about 28 police majors.

- (3) During my term of service, I hope to reduce the prison population and hope that the prisoners can learn a trade and not return to prison.
- (4) I do not see any possible conflicts of interest that could arise during my service on the Correctional Industries Advisory Committee. Based on my background. If there was a conflict of interest I would resign.
