As to question number one

I wish to be a part of this committee because having served on many boards in the past as well as currently I feel as though when asked, and you are able you have an obligation to do so and I have always found public service to be very rewarding and feel I can bring a different view to the committee.

As to question number two

I believe that I am qualified for this position because in my position as the President of a large labor organization as well as my involvement on other boards and commissions I have a good understanding as to the climate of our economy and our employment market, and because I feel that those in our incarcerated community are a very underutilized workforce in our state and in a tough economy such as the one we are in now I feel the need to make use of this manpower to both ease the cost burden to the public but more so to help train these inmates to be successful contributing members of our community upon their release so that they don't continue on with this terrible cycle.

As to question number three

I hope that with the other members of this committee we can work together with both the department of public safety and the public to build a strong relationship and develop programs that would be beneficial to all parties involved as well as those that are incarcerated, because if we do not then we are destined to repeat this same cycle of inmates using the prison system as a revolving door.
