The Department of Human Services (DHS) supports the nomination of Mr. Walter Yoshimitsu to the State Commission on Fatherhood.



Chair Chun-Oakland and members of the Senate Committee on Human Services, I truly appreciate this opportunity to appear before you today. I thank Speaker Calvin Say for submitting my name for consideration, and Governor Abercrombie for selecting me for possible confirmation. In addition, I am grateful to all the people in the community who took the time to submit testimony on my behalf.

Let me begin by saying that I am a proud father of five children. I believe that the school of "hard knocks" makes me qualified to serve on this commission. The experience of raising my children will help me to contribute to furthering the importance of fatherhood. Educating the public on the importance of family life, and specifically what it means to be a father, means a great deal to me.

In the community, I use this passion in the duties I perform as an assistant chaplain at the Halawa Correctional Facility. It doesn't stop there as I also volunteer my time at the women's facility. In that capacity, I see firsthand the hardship caused by broken families. I see father and son in the same facility, children being brought up in single parent households or foster care, and many youth and young adults looking for guidance and support. Studies show that individuals raised in this volatile atmosphere are more likely to stray.

Over the years, I have seen that a father that bonds with his children in a positive way has a tremendous impact on their upbringing. This strong belief gives me the ability to empathize with fathers and in their decision making.

An important part of the work of this commission is in educating the public. Time and time again I hear people say that they think that it is the mothers job to raise children and in that manner down play the integral role of the father. Having workshops with fathers telling their "success story" is an important method for educating the public — and thereby dispelling that myth.

Even before a couple is married, the education begins. I help in the preparation of marriage to let the couple know the importance of permanency in their marriage. With the divorce rate as high as it is, it is very important that we try to reduce the number of broken families in our community. Children from broken relationships have a challenge to overcome. In the preparation process, we present issues of finances, in laws, difference on issues and how to possibly deal with them.

On a personal note, the commission will find that I am a good listener and most of the time I can relate to the couple because I have "been there, done that." I know that I can be a contributing member of this commission and would love the opportunity to do so. I thank this committee for the work that you do for the state and affording me the opportunity to be here. I ask for your support in confirming my nomination.
