Chairman Green and members of the Senate Health Committee:

My name is Nathan Chang and I am submitting this testimony in relation to the confirmation of my appointment by Governor Abercrombie to serve as a member of the Hawai'i Health Authority.

As you will see in my enclosed resume, I have been a professional social worker in Hawai'i for the past 37 years. Originally trained as a medical social worker, I was employed in a variety of positions at Catholic Charities for the first 14 years of my career. After leaving Catholic Charities in 1989, I joined the faculty at the University of Hawai'i School of Social Work and I spent the next 23 years as a social work educator. I have, in essence, committed the better part of my life in service to the community.

When I was asked by Representative Yamane last year if I would accept a nomination to the Hawai'i Health Authority, I was admittedly surprised. I did not see myself as the most qualified person for this position and I still don't. However, I accepted the nomination because Representative Yamane had faith in my judgement and we both agreed that it was critical to ensure that someone on the board would focus on the issue of social and economic justice. I don't know why Speaker Say chose to pass my name on to the Governor, or why the Governor ultimately chose to appoint me to the Hawai'i Health Authority. I can only speculate that they agreed with Representative Yamane's perspective.

It is my understanding that the Hawai'i Health Authority is charged with the responsibility "for overall health planning for the State and...for determining future capacity needs for health providers, facilities, equipment, and support services providers." Section 322H further specifies that "The authority shall develop a comprehensive health plan that includes: 1) Establishment of eligibility for inclusion in a health plan for all individuals; 2) Determination of all reimbursable services to be paid by the authority; 3) Determination of all approved providers of services in a health plan for all individuals; 4) Evaluation of health care and cost effectiveness of all aspects of a health plan for all individuals; and 5) Establishment of a budget for a health plan for all individuals in the State. As such, the primary task for the Hawai'i Health Authority is the development of a system for the State of Hawai'i that will ensure that all of its residents have access to adequate health care.

I believe that I am qualified to assist in this endeavor. I am committed to the principle of social and economic justice for all people – which includes the idea that everyone should have access to adequate health care. And I stand willing to serve on the Hawai'i Health Authority if this committee sees fit to confirm me.
