Dear Senator Green and Members of the Senate Health Committee:

The following is a statement in which I have tried to address the questions provided. Thank you for the opportunity to assist you with the confirmation process.

In order for the people in the state of Hawai'i to have optimal health status, the Hawai'i State Department of Health must function at an optimal level. My expertise is in the field of public health and I very much want to apply my skills and knowledge towards this end. I believe I have the background, knowledge, and expertise to be able to make substantive contributions to the Board of Health. I look forward to the Senate's positive consideration of my nomination to serve as a member of the Board of Health.

As a member of the Board of Health I will provide key advice and recommendations to the Director of Health to help the Director in making appropriate decisions to provide optimal public health and preventive medicine services to the people of Hawai'i.

I believe I am uniquely qualified to serve as a member of the Board of Health. I am currently Professor and Chair of Graduate Studies for the Department of Public Health Sciences, John A. Burns School of Medicine, University of Hawai'i. I have been a faculty member in public health (initially with the School of Public Health and then with the School of Medicine) since I was hired by the university in 1988 as an assistant professor. I am a physician with an MD degree from the University of California, Irvine (1980) and am a licensed physician in the state of Hawai'i. I also earned a masters degree in public health from the University of Hawai'i's School of Public Health (1987). I am board certified in Preventive Medicine and General Public Health and hold "Fellow" status in both the American College of Preventive Medicine and the American College of Epidemiology. Prior to joining the University, I served as Director of the AIDS/STD Prevention Program in the Hawai'i State Department of Health from 1987-1988. The Prevention Program was transitioning to "Branch" status during this interval. I also served as a staff physician at the Waikiki Health Center, a federally qualified community health center, from 1983-1987 and was their medical director from 1984-85.

During my term of service on the Board of Health I hope to contribute to and help the Department of Health in its mission to protect and improve the health and environment for all people in Hawai'i.

Three qualities that describe me and make me stand out are my dedication, altruism, and empathy. These are the attributes that led me to pursue a career in academic medicine and public health. These attributes coupled with my academic, medical, and public health background will allow me insights and understanding to provide thoughtful advice to the D irector of Health and benefit the Board of Health. A single experience that has made me stand out is my service as Graduate Chair for Public Health Studies at the University of Hawai'i over the past six years. In this capacity I have had the opportunity to work closely with all of our graduate students and faculty and serve as a liaison to maintain an excellent academic program. I have also had the opportunity to spearhead the development of new academic programs, such as our new MD-MPH program, and have provided focused career counseling for our students to help them navigate the best path to meet their future career goals.

I do not believe I have any potential conflicts of interest. Public health has been my passion and my professional life. I have worked closely with many members of the Hawai'i State Department of Health and believe that I have cultivated a positive relationship with my department colleagues.

In sum, I believe that Dr. Katz's training and experience as a physician and epidemiologist provide him with the knowledge base and perspective to allow for a thorough understanding of the complex issues facing the Department of Health. He will provide outstanding service to the Hawai'i Board of Health.
