Dear Senator Green,

Thank you for your consideration of my nomination for the Health Planning Council, Honolulu Subarea. This document contains my answers regarding the personal statement questions listed in the nomination letter sent on February 24, 2012.

1) Why do you wish to be a member of the Health Planning Council, Honolulu Subarea?

I believe it is both an honor to be asked and a civic duty to participate in our State's boards and commission such as the Health Planning Council, Honolulu Subarea. I joined the subarea about 4 years ago and have learned about our health service system during that time. I understand and appreciate that it takes community participation to address the issues and have a high level of affordable health care for the residents of our state.

2) How do you perceive the role and responsibilities of a member of the Health Planning Council, Honolulu Subarea?

The main role of the council is to provide community input in the Certificate of Need (CON) application review process in our subarea. It is a member's role to provide an objective and balanced evaluation of the CON applications to minimize health care cost while providing for the healthcare needs of the community. It is the responsibility of members to become knowledgeable about the state's health care system and use good judgment in the CON review process.

3) Given your understanding of the role and responsibilities of the Health Planning Council, Honolulu Subarea, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Health Planning Council, Honolulu Subarea.

My educational and professional background is technology-related and not specifically in healthcare. I believe this to be an asset as my line of work allows me to be objective and also provide expertise in a field that can be of benefit to the healthcare industry. I have previously worked with various businesses and government entities including the State of Hawaii, the University of Hawaii, GTE Hawaiian Tel and some smaller local companies. I have a graduate degree in business administration

and also have first-hand experience in starting and managing small businesses. I believe these give me a good set of experiences and education to draw upon when reviewing CON applications and participating in the council.

4) What do you hope to accomplish during your term of service?

I hope to continue educating myself about our healthcare system and collaborating with other members of the council on the various healthcare-related activities of the council.

5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Health Planning Council, Honolulu Subarea?

Tech-savvy - Being in the technology field provides some technical expertise to the council.

Problem-solver - As an IT consultant, I have experience working with different groups in solving problems by identifying and setting goals and making decisions objectively with the various stakeholders.

Collaborative - Working with others collaboratively is important in getting things done since our healthcare system is incredibly interrelated and complex.

I believe that having worked in both the public and the private sector (both large and small companies) lets me bring a balanced and realistic perspective to the council.

Since I do not work in the healthcare industry, it reduces my possibility of being in conflicts of interest situations during CON reviews. If a conflict of interest does arise, I will inform the council of it and recluse myself from the decision making as expected of any council member.
