3. Given your understand of the role and responsibilities of a member of the Health Planning Council, Windward Oahu Subarea, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Health Planning Council, Windward Oahu Subarea.

While serving 6 years on the Ko'olauloa Community Health and Wellness Center as President, we have grown from a small one provider site providing services from a rented trailer, to two sites, one of which we own. We have also purchased a pharmacy and added a dentist to our operation. My expertise is in business, I have a real estate license and have owned and operated several businesses throughout the years. When I worked as the Human Resources Manager for a manufacturing company that at the time had 250 employees, I used my knowledge of laws, as a paralegal to effectively maintain compliance of OSHA regulation, recording onthe-job injuries and working with the clinic and doctors we had them go to for medical attention until they came back to work. I work well with people and believe that I have the ability to make good and sound decision that will be a benefit to the Health Planning Council, Windward Oahu Subarea.

4. What do you hope to accomplish during your term of service?

I would hope to achieve increase access to health care in my community and insure that we are providing a well-informed perspective on medical reform issues.

I have already demonstrated a commitment to spending the time needed to become informed about local health care issues by attending conferences and seminars and working with our health center. I am able to represent local needs fairly and clearly. I am very organized and will be very professional in handling my responsibilities as a member of the Council.

6. Name one previous experience that would make you stand out. How would this benefit the Health Planning Council, Windward Oahu Subarea?

My experience as a member of the Board of Directors of a Federally Qualified Health Center, FQHC that are designed to have community involved in the decisions about the services needed in the community, additionally I have served as a member of the Accountable Healthcare Alliance of Rural Oahu (AHA-RO). The AHARO is a "virtual accountable care organization" responsible to the community elected governing boards of the three FQHC's of Oahu: Ko'olauloa Community Health and Wellness Center, Waimanalo Health Center, and Waianae Coast Comprehensive Health Center. These three Health Centers serve a total of approximately 40,000 patients through over 200,000 clinical visits annually. Approximately 50% of these patients (20,000) are enrolled in the Hawaii Quest (Medicaid) program. It is the intent of AHARO to assure that performance-based health care is fair to safety net providers and results are accountable to the patients served as well as to payers.

7. Can you foresee any possible conflicts of interest that could arise during your service on the Health Planning Council, Windward Oahu Subarea? How would you overcome any possible conflicts of interest?
