Mahalo for your consideration of my nomination by Governor Neil Abercrombie to serve as a commissioner of the King Kamehameha Celebration Commission. The following information is provided as requested:

- b. A written statement that addresses the following questions:
- (1) Why do you wish to be a commissioner of the King Kamehameha Celebration Commission? To contribute to the commission's mission to realize an outstanding celebration in honor of King Kamehameha, and to honor and respect those before me who founded the celebration and the groundwork that they have established, most especially the organization that nominated me, Hale O Nā Ali'i O Hawai'i Ahahui Po'o. (The kaona of my nomination, because Aunty Harriet Smith, Iku Ha'i of this organization asked me to serve and I do so out of friendship in respect to her.)
- (2) How do you perceive the role and responsibilities of a commissioner of the King Kamehameha Celebration Commission, particularly in terms of your nomination by Hale O Nā Ali'i O Hawai'i Ahahui Po'o? I perceive the role and responsibilities of a commissioner to be to plan appropriate celebratory events in memory of King Kamehameha I and to assure that resources are available to execute such activities. Additionally, to set policy where needed that is not in conflict with Hawai'i Revised Statutes 8-5, King Kamehameha Celebration Commission or to make recommendations for change, where needed. In terms of my nomination by Hale O Nā Ali'i O Hawai'i Ahahui Po'o, my role is to serve as a conduit of information about the planned activities and to seek the support of volunteers from this organization. Additionally, in decision making to represent the mana'o of members of Hale O Nā Ali'i O Hawai'i Ahahui Po'o and to respect and learn from the experiences of past members of the Commission who have set the framework for our mission.
- (3) Given your understanding of the role and responsibilities of a commissioner of the King Kamehameha Celebration Commission, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a commissioner of the King

Kamehameha Celebration Commission. I believe that I am qualified for the position because I have over 50 years of managerial and leadership experience both in the federal government and in the Hawaiian community. However, the most important attribute I bring is the ability to communicate with the Native Hawaiian community and to be objective in decision making, having considered all facts. Also, because of my experience as chair of the Prince Kūhiō Festival, a month-long celebration in honor of Prince Kūhiō, and as the former president of the Association of Hawaiian Civic Clubs, I am sensitive to Native Hawaiian values and cultural protocol.

- (4) What do you hope to accomplish during your term of service? My sense is that the commission has done a good job, especially on O'ahu. During my term of service, I hope to contribute to updating the Hawaii Revised Statute and Administrative Rules concerning the Commission, to assure written processes are in place to assure continuity of policies and procedures established, to assure proper funding of the activities, and to build neighbor island celebration activities.
- (5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the King Kamehameha Celebration Commission? 1) Aloha, a caring for all; 2) Lau Lima, pitching in to do the work; 3) Pono, being objective and informed in decision making. I believe these qualities are necessary to contribute to the whole team in execution of our responsibilities.
- (6) Name one previous experience that would make you stand out. How would this benefit the King Kamehameha Celebration Commission? Observing my mother and father's love for our Native Hawaiian culture and being taught through hula by my teachers the importance of understanding the history and stories of days passed and how they shaped our lives, and understanding through my Japanese mother and Portuguese father that Hawai'i is comprised of a diverse community and the King Kamehameha Celebration embraces all, but reminds us of our roots as Native Hawaiians.
- (7) Can you foresee any possible conflicts of interests that could arise during your service on the King Kamehameha Celebration Commission? How would you overcome any possible conflicts of interest? I do not foresee any conflicts of interests that would arise during my service on the King Kamehameha Celebration Commission.
