The Department of Land and Natural Resources (Department) fully support of Governor's Message 729 on the nomination of Mary Buza-Sims to the Kōke'e State Park Advisory Council.

Ms. Buza-Sims was born and raised in Kekaha. As a child and an adult, she lived at the foothills of Kōke'e, where she and her family camped and enjoyed its beauty. In 1972, she got her Bachelor of Arts Degree in Education from Seattle University and continued graduate work at the University of Washington wherein she received a Master's in Social Work.

Ms. Buza-Sims started her career as an educator in 1974 when she held the position of Teacher Trainer in Seattle, Washington. She has also served as a Board member for St. Joseph Elementary School in Seattle and was Board member and Chair of E Ola Mau Na Leo O Kekaha.
