The Department of Land and Natural Resources (Department) fully supports Governor's Message 732 on the nomination of Val Tsuchiya to the Kōke'e State Park Advisory Council.

Mr. Tsuchiya was born and raised in the town of Waimea and spent much of the time playing in Waimea Valley, Waimea Canyon and the Nāpali Coast. In Kōke'e, he hunts for pigs, deer, and goats and fishes and free dives along the Nāpali Coast. He has been on nearly every trail in Kōke'e and Waimea Canyon, and frequently blazes his own trails.

A graduate of Colorado State College where he earned a Bachelor's Degree in Social Science, he subsequently joined the United States Army. Making use of the GI bill, he worked towards a Master of Arts Degree and an Ed.S in Special Education from the University of Northern Colorado.

Mr. Tsuchiya began his career as an educator teaching social studies and science to 7<sup>th</sup> and 8<sup>th</sup> graders at Kekaha Elementary School in 1968. From 1972 through 1979, he instructed secondary students with learning, emotional, and other identified disabilities, including mental retardation, health, and hearing impairments. For the next ten years, he worked with elementary aged students needing special education at Kalaheo Elementary School. From 1989 to 1997, he became a resource teacher, providing technical support to schools, Special Education teachers, counselors, and administrators and from 1997
