Chair Espero, Vice Chair Kidani, and Members of the Committee:

The Department of Public Safety (PSD) strongly supports the nomination of Bert Matsuoka to the Hawaii Paroling Authority (HPA), term expiration of June 30, 2016.

Mr. Matsuoka holds a Master's degree in Public Administration and Bachelor's degree in Sociology from UH-Manoa. Mr. Matsuoka's career includes over 20 years in public services which he began as a metropolitan police officer with the Honolulu Police Department, and moved to state service in 1980 as an investigator with the Department of Human Services (DHS) welfare division. Mr. Matsuoka was promoted to manage the DHS Restitution Control Section where he coordinated and conducted criminal and administrative investigations. In 1992, Mr. Matsuoka administered the DHS Volunteer Services Office where he was active in various community events that introduced him to many volunteers. In 1993, he joined the Office of Youth Services (OYS) as the Youth Gang Project Coordinator and in January 1995 was appointed the OYS Executive Director by then Governor Ben Cayetano. As Executive Director, Mr. Matsuoka worked closely with

community-based organizations that provided services to children and youth. He was respected for his collaborative endeavors with the community, including advocating for and initiating new opportunities for Hawaii's youth.

Mr. Matsuoka's experience also includes being a Hawaii Department of Defense civil defense planner, during emergency events which he was responsible for planning and coordinating with the myriad of agencies, both public and private, which are first responders. Again, this required he draw on his ability to effectively collaborate with others and ensure protection of the public during civil defense emergencies.

Mr. Matsuoka is also a member of the U.S. Coast Guard Auxiliary and a board member of the Moiliili Hongwanji Mission, in addition to participating in community service projects in East Honolulu.

Finally, as this Committee is aware, Governor Neil Abercrombie is in strong support of the Justice Reinvestment Initiative (JRI) that is premised on managing the growth of correctional populations through: 1) valid risk assessments to determine which offenders are better served in community-based programs as opposed to incarceration; 2) evidenced-based approaches, programs and services that do not jeopardize public safety yet reduce admissions to corrections and reduce the length of stay in a correctional facility; 3) expand victim services in all counties; and, 4) reinvest savings generated from reduced corrections spending into communities. PSD is working to return home Hawaii inmates placed out-of-state by developing and implementing a comprehensive reentry plan that will expand and improve in-facility that includes expansion of in-state capacity and community-based programs to prepare inmates for their successful reintegration into the community. HPA is an integral part of the JRI and the reentry process. Mr. Matsuoka has been an integral part in developing a system that promotes public safety through effective and evidenced-based programs for transitioning inmates.

In my view Mr. Matsuoka has been and will continue to be a thoughtful, effective, caring and diligent Chair. I suggest he should be retained without reservation or exception. He is a good man, a committed public servant, an experienced Chair and quite knowledgeable in the criminal justice system.

Let me be specific. Since July 2011 he and I worked together as colleagues hearing a variety of HPA cases involving minimum settings, parole hearings, parole revocations, and other HPA business. Mr. Matsuoka was always well prepared, punctual, cordial and attentive to the correct procedures. He gives those appearing before the Board, including the inmates, victims, attorneys and staff, a fair hearing. We sit some 16 to 20 days monthly and often there are some 20 + cases calendared each day. We visit some nine (9) different facilities most months including Saguaro in Arizona by video, the neighbor islands and the Federal Detention Center.

What I most appreciate is Mr. Matsuoka's ability to manage and encourage the diversity of views by the current Board with an eye toward consensus. This diversity in my view allows for full and fair discussion by the Commissioners. We usually are unanimous in our final decision, which demonstrates how effective Mr. Matsuoka is in guiding the Board. Also of importance to me is his exemplary attention to the staff of the HPA including administration, parole officers and staff. For the first time ever, we met statewide in Honolulu so the various staff could meet each other, hear from the Chair and appreciate this team approach. Of course, when it comes to public safety and individualized decisions, there is always will be room for some controversy. Great collegiality and cooperation are the order of the day.

Chair Espero, Vice-Chair Kidani and members of the Senate Public Safety, Government Operations and Military Affairs Committee thank you for the opportunity to appear before you today.

I want to first thank Governor Neil Abercrombie for again nominating me to the Hawaii Paroling Authority (HPA). It is an honor and a privilege to be considered for the position of Chairperson of the HPA.

I also want to extend my appreciation to all who submitted testimony on my behalf and to those here in attendance offering their support.

It was just about a year ago that I appeared before you for a confirmation hearing for this position. Because the appointments of the three (3) Parole Board members are staggered to maintain continuity in Board membership, I'm again before you for confirmation.

Before I go on, I need to express much mahalo to my two colleagues, Parole Board members Ms. Joyce Matsumori-Hoshijo and Judge Michael Town. Both are truly outstanding individuals who have helped me tremendously with their knowledge and experience. I feel that our Parole Board is a great team. I also want to acknowledge Mr. Tommy Johnson and the entire staff of the Hawaii Paroling Authority for their support and patience with a "rookie" Chair this past year. And I'm very appreciative of Director Jodie Maesaka-Hirata for all she and her Department have done to support the HPA and me.

The past year has been exciting, challenging and a real learning experience for me. I have observed the excellent work done by the staff of the HPA. However, I will caution that before we can commit on taking on new ideas and programs, we need to be sure that we're prepared to make it work. To attempt new ventures without personnel, infrastructure and resources would jeopardize current HPA mandates and not afford a new program a fair opportunity to succeed.

This is in response to your letter dated April 2, 2012 requesting information regarding my nomination to the HPA by Governor Neil Abercrombie.

The following are my responses to your questions:

### Why do you wish to be a member of the Hawaii Paroling Authority?

I have over 30 years of public service; most of those years were spent either in criminal justice, juvenile justice, or administrative/management positions. Those are areas that I have personal commitment and interest in. The HPA plays a critical role in our community's well-being and I believe I can continue to contribute by making sound Parole Board decisions and also help guide the HPA to become an even more effective and efficient State agency.

2. Given your understanding of the role and responsibilities of a member of the Hawaii Paroling Authority, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Hawaii Paroling Authority.

My experience and character allows me to view situations in an objective manner. With regard to the specific situations facing the Parole Board, I can bring a balanced approach in determining decisions. My law enforcement experience coupled with my social services background will allow me to view a situation with minimum bias. I will place emphasis on the collected research, data, and history of the individual, and seek the input from the professionals who actually work with and represent the individual. I will also take into consideration information and comments from law enforcement and the victims of the crimes.

I won't be intimidated by either the inmate or the establishment in making decisions. When decisions are based on accurate information, established "best practices," and clear objective views, you will have appropriate and responsible outcomes.

As stated earlier, I believe the combination of my experience, character, and education affords me a range of attributes that contributes to my qualifications.

I was appointed by former Governor Ben Cayetano to an eight-year term as the Executive Director (ED) of the Office of Youth Services (OYS). My experience as a Honolulu Police Officer and Supervisory Investigator with the Department of Human Services has also contributed to my understanding of the criminal justice system in Hawaii. I also have many years of working with the State Legislature, various State and County agencies, the Judiciary, and numerous community and non-profit organizations.

In addition to previous positions, my education includes a Masters Degree in Public Administration and a Bachelors Degree in Sociology, both from the University of Hawaii – Manoa. I also attended the Masters of Social Work program at UH-Manoa where I did my practicum as a juvenile probation officer with the Family Court.

### 3. What do you hope to accomplish during your term of service?

Having now been the Chairperson for over a year, I have observed the good work done by the HPA. These are very dedicated and committed professionals who strive to maintain the high standards required of the HPA.

If afforded the opportunity to continue, I want to help the HPA to positively move forward. I will work collaboratively with all segments of the staff and look at areas where we can strengthen and improve the agency. I believe this can be accomplished with good communication and networking, not just within the HPA, but reaching out to other entities that have a part in the entire parole process.

The "process of parole" needs to be recognized as complex and multi-faceted. I believe improvement in the parole process cannot occur with the HPA operating alone. Positive strides will occur when there are more working partnerships with the Department of Public Safety, other government agencies, non-profit organizations, and community groups all contributing and who share this endeavor.

With the assistance of the other Board members, and the staff of the HPA, I believe that we can begin the movement in this direction.

4. Can you foresee any possible conflicts of interests that could arise during your service o the Hawaii Paroling Authority? How would you overcome any possible conflicts of interests?

If faced with a potential conflict, I will take myself out of the situation. And if assistance is needed in determining the proper action, I will consult with the Department of the Attorney General and/or the Office of the Governor.
