I am also a graduate Civil Engineer and licensed in the State of Hawaii. I have a Distribution System Operators Certification Grade 4 for over 11 years in the state of Hawaii. Currently, I am the Assistant Chief, Division of Road Maintenance for the City and County of Honolulu.

 - a. I hope to accomplish reviewing applications and recommending for approval the qualified individuals to take the exam to achieve certification.
