Chair Chun-Oakland, Vice Chair Ihara, and members of the committee, thank you for this opportunity to provide testimony in support of Governor Message 781, submitting for consideration and confirmation to the Early Learning Council, Gubernatorial Nominee, ALFRED CASTLE, for a term to expire 6-30-2014

Alfred Castle, the Governor's nominee to represent the philanthropic sector on the Early Learning Council (ELC), has been dedicated to building a comprehensive, integrated high quality early learning system in Hawaii for the last 14 years. In 1998, Mr. Castle returned to Hawaii from California, where he was the Vice President and adjunct professor of history in the California State University System, to take the helm at the 120-year old Samuel N. and Mary Castle Foundation. That same year, he began an active partnership with the Good Beginnings Alliance and most recently has been serving as a member of the ELC's finance committee. Widely respected by pre-school directors across the state, Mr. Castle has sponsored numerous professional development opportunities for directors and teachers. He created an important low-income tuition assistance program for families having trouble paying tuition at high quality accredited centers.

Mr. Castle is a distinguished pioneer philanthropist who is a key contact with mainland funders such as the Pew Charitable Trusts and the WK Kellogg Foundation. In a national election by national foundations funding in early education, he was elected with the CEO of the Heinz Charitable Trust of Pittsburgh to serve on the governing board of the National Early Education Funders Collaborative in Washington, DC. He is also a past trustee of the Grantmakers for Children, Youth and Families (GCYF) in Maryland. He has been a tireless fund raiser and promoter of Hawaii's causes with his local and mainland foundation peers. In 2006, Mr. Castle chaired the Council on Foundations National Foundations Conference.

Mr. Castle is an ideal link between the public and private sectors to build a high quality,

integrated, comprehensive education system. His experience has included, being the key initiator of our Pre-K-grade 3 efforts by lobbying the Kellogg Foundation to commit to educational reform in our state. His \$10,000,000 matching pledge helped to persuade Kellogg to commit to numerous projects in our state. Last August, he partnered with my Administration by providing some of the funding needed to hire a team for the writing of our State's Race to the Top Early Learning Challenge application. Most recently, his collaboration with our Department of Human Services, the University of Hawaii's Center on the Family and the Kellogg Foundation to create an important and culturally-sensitive Quality Improvement and Rating System to enhance the quality of early childhood programs, received national recognition and will be featured at their annual conference of foundations of GCYF in El Paso, Texas in October. Finally, Mr. Castle works well across cultural communities locally and nationally.

Therefore the Abercrombie Administration is in strong support of Alfred Castle as the philanthropic representative for our state Early Learning Council.



## Testimony of Alfred L. Castle to the Senate Committee on Human Services on March 27, 2012

Submitting for consideration and confirmation of the gubernatorial nominee Alfred L. Castle for a two-year term starting July 1, 2012 to the Early Learning Council.

Chair S. Chun Oakland and members, thank you for the opportunity to be considered for the philanthropy representative on the Early Learning Council.

I am grateful to Governor Abercrombie for nominating me. The opportunity to serve Hawaii's children and families through this hybrid public-private council is important as our state has a chance to create an improved comprehensive system of health and education for children.

Since 1836, the Castle family has invested substantial time and treasure in serving our state. In 1894, my great-great grandmother established one of America's oldest charitable foundations dedicated to the education of young children. In 1998, I returned from the California State University System where I was an executive to become executive director of the Samuel N. & Mary Castle Foundation.

Since my assuming the post, I have worked tirelessly to improve the education of children 0-5. To that end, I have initiated numerous programs in pre-school directors training, curricular design, outcomes evaluation, pre-school infrastructure improvements, and system building and advocacy through Good Beginnings Alliance. I have and continue to serve on national boards which has enabled me to advocate for foundation funding for Hawaii's children. The many Kellogg Foundation initiatives underway in Hawaii started with a \$10,000,000 from the Samuel N. & Mary Castle Foundation to attract a \$10,000,000 grant from the Kellogg Foundation (see Foundation web site at

www.fdncenter.org/grantmaker/castle for full information about my grants strategy). Well connected to Hawaii's philanthropy as it relates to children and families, I am situated well to inform my colleagues both on the ELC and in the philanthropic community how public and private dollars will be needed to increase access to quality education, narrow the achievement gaps, and to ensure the basic health and safety needed for community well being.

I have served on numerous boards on the mainland as well as in Hawaii. These include Good Beginnings Alliance, the Hawaii Humanities Council, Academy of the Pacific and Hawaii School for the Girls. I am well read on the historical and current issues in early education and have written and spoken widely on these issues. Working with the Hawaii Business Roundtable on the "Be My Voice Campaign" and as co-chair of the Keiki Funders Network, and as a member of the ELC's Finance Committee, I work well with pre-school providers, teachers, foundation executives, donors, mainland foundations and legislators.

The key role of the ELC is to advise and assist the executive office of Early Learning and the Governor on key legislative initiatives relating to the education and well being of children. The ELC is a key link between government and the large and diverse private sector. In my 2-year term I hope to substantially advance the connectors between public policy and private financial investment and advocacy. I do not see any conflict of interest in my service but would quickly declare it if I did see it.

Bringing the qualities of (1) <u>understanding</u> of the key issues faced by teachers, children and families, (2) <u>knowledge</u> of the private funding world both in Hawaii and on the mainland, and (3) my <u>awareness</u> of the historical origins of our current circumstances I believe I would be of major assistance to the vital work of the ELC.
