# Testimony of Azita Quon Submitting for Consideration and Confirmation To The Senate Energy And Environments Committee Gubernatorial Nominee, Azita P. Quon For a Term to Expire on June 30, 2016

Honorable Chair Mike Gabbard and members of the Committee, thank you for the opportunity to appear before you today.

I want to thank Governor Neil Abercombie for nominating me. This will be my first time in public service and I am truly honored to serve as a member of the Environmental Council.

I want to also extend a great mahalo to friends and colleagues who submitted letters of support on my behalf.

In the early 80's, like many others who make Hawaii their home, I first came to Hawaii as a visitor. What brought me back year after year was the simple beauty of the islands. I eventually married a local Kama'aina from Hawaii and settled in Oahu. We are proud older parents of a thirteen year old daughter who is a typical teenager, born in the digital world, totally at ease with technology. When I told my daughter that I was nominated to serve the Environmental Council, she told me I should read the paper she researched and wrote a year ago on why we should protect our environment in Hawaii. When she was six years old in kindergarten, she was learning about the 3-Rs of the environment 'Reduce', 'Reuse', 'Recycle' and she was teaching <u>us</u> why we should not waste 'running water' and 'electricity', and why we should grow our own 'food'. She and her generation serve as my daily reminder of why we should protect the environment, especially that of our beautiful islands.

My educational and professional background is architecture. I graduated from the University of Oregon with a 5-year bachelor degree in architecture in 1980 at a time of rising gasoline prices due to foreign oil dependency. My first job in Oregon was to administer a federally funded DOE program which gave Hospitals and Schools grants to implement renewable energy measures and to retrofit their existing facilities to become more energy efficient and independent.

I have been part of the architectural community in Hawaii since the building industry boom of the mid 80's and have had over 25 years of practice with some of the very best architectural firms. Significant influences in my career in Hawaii are numerous. One of my early positions was at Vladimir Ossipoff's firm where I learned to appreciate his deliberate sensitivity to environment present in all of his work. Use of regional materials and craftsmanship, indoor outdoor living, building orientation that took advantage of what each site had to offer. I worked for the firms of Wimberly Allison Tong and Goo and Hemmeter development which brought Hawaii's resort architecture to the forefront in the world.

In 1996, after I received an MBA degree from University of Hawaii with a focus in real estate development I got more drawn to design strategies driven by a vision and awareness towards preserving and maintaining a strong sense of community, preserving environmental quality for people and communities, preserving precious mauka-makai vistas, encouraging open space and landscape design in high density urban areas, and green sustainable approaches to architecture and development. I joined the firm of Architects Hawaii and for the next nine years I was able to work on a number of very significant buildings in Hawaii. Working with Mr. Joe Farrell I was involved in realizing some of the first high density high-rise residential developments of the decade-*Lanikea Towers* in Waikiki, and the *Moana Pacific* in the Kakaako district. I was able to design green sustainable approaches to architecture and development in the *Kapolei Judiciary Building* and the *Kamehameha School's PE and Athletics Building* with architects David Bylund and Terry McFarland.

In 2009, encouraged by the 'Green Building movement', I became LEED certified. I continue to practice architecture with the 'Green' design at heart, knowing that it has the promise of environmental, economical and social benefits that impact all building stakeholders, including owners, developers, builders and the general public at large. Most recently with the Planning Team of Parsons/AECOM and NAVFAC Pacific, I was involved with the master planning efforts for the new base for relocation of Marines from Okinawa to Guam, worked closely with the Sustainability team leaders and experts to address federal mandates and recommend green approaches to site development, water efficiency, and energy reduction.

While it is so encouraging to see an increase in Hawaii's awareness towards Green building standards for sustainable site development and building design, water savings, energy efficiency, materials selection and indoor environmental quality, it is still up to individuals, business owners and professionals to make a contribution towards reducing our environmental footprint in the way we live and do business. My source of inspiration is our sons and daughters. On an individual level, I hope to be able to assist the *Environmental Council* (EC) and the *Office of Environmental Quality Control (OEQC) to* achieve its goals and make a contribution towards protection of Hawaii's environment for our future generation. A written statement that addresses the following questions:

(1) Why do you wish to be a member of the Environmental Council?

I have been part of the architectural community in Hawaii for over 25 years. Hawaii is my home and I welcome the opportunity to serve the community and contribute my expertise to creating a better place for the children of Hawaii. I understand the profound impact the built environment has on our natural environment, economy of the State, as well as on the health and well-being of the community. As a citizen, I stand for the protection and quality of the environment we live in. My thirteen year old daughter is my constant reminder of why we should care for Hawaii.

(2) How do you perceive the role and responsibilities of a member of the Environmental Council?

EC is a liaison between the OEQC and the public on environmental issues. The Council represents the public's interest on those issues that impact the environment. I understand this responsibility. As an architect and planner, I am continuously challenged to design a project that reflects the delicate balance between programmatic needs, the effect of the building on its site and surroundings, and creating a facility that will be good for Hawaii's community now and for future generations. The role and responsibilities of the EC's members are to be an advocate for public interest and contribute to fair and sensitive solutions on environmental issues that will create positive outcomes. The whole community well-being is ultimately what matters.

(3) Given your understanding of the role and responsibilities of a member of the Environmental Council, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Environmental Council.

I have the educational and professional background, experience and expertise in architecture and planning. I am a registered architect in the State of Hawaii and am LEED certified (Leadership in Energy and Environmental Design). Under the US Green Building Council's leadership, LEED has come a long ways since its inception. It has been embraced

by the industry players, owners, developers, builders and has given the tools and knowledge and standards to design and build Green buildings and communities that can maximize both economic and environmental performance.

I graduated with a bachelor degree in architecture from the University of Oregon. My first job in Oregon was to administer a federally funded DOE program which gave Hospitals and Schools grants to implement renewable energy measures and to retrofit their existing facilities to become more energy efficient and independent. When I first came to Hawaii, one of my first mentors in architecture was Vladimir Ossipoff. I learned to appreciate his deliberate sensitivity of integrating a building into its environment, the use of regional materials and craftsmanship, indoor-outdoor living and building site orientation.

Over the span of some 20 years, I have been fortunate to have worked with some of the more notable architects and firms in Honolulu. I worked for the firms of Wimberly Allison Tong and Goo and Hemmeter development which brought Hawaii's resort architecture to the forefront in the world. At Architects Hawaii, I was able to work on a number of very significant buildings in Hawaii implementing sustainable approaches to architecture - seeking harmony in site design and building orientation to maximize human comfort and well-being, to respect the locality's sense of place through use of regional materials and local craftsmanship, and looking for ways to reduce energy usage and use of renewable energy.

(4) What do you hope to accomplish during your term of service?

The following are important targets: updating the rules that trigger EIS; updating the list of Exemptions under the EIS; making recommendations to the State and support legislation that protects environment.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Environmental Council?

Three qualities are as follows:

- Over 25 years of experience as an architect and planner in the building industry and in Hawaii. Offer the EC this expertise and experience. Architecture plays an important role in shaping the environment and in the quality of the environment.
- As an architect, we are trained to sift through parameters and challenges and be a
  problem solver. We have learned to be good listeners, to review and analyze facts,
  find reasonable and sensitive solutions. Offer these attributes in formulating
  decisions at the EC.
- Knowledgeable in LEED and sustainable approaches to the built environment.
   Offer the EC this expertise.

(6) Name one previous experience that would make you stand out. How would this benefit the Environmental Council?

My recent experience with the master planning for the Guam Build-Up. It furthered my understanding of how: 1) Sustainability plays an important part in the planning of the proposed Base; 2) the complexity of the EIS process for a project of this significance. The Department of the Navy prepared the Draft EIS to access the potential environmental effects associated with the Guam Build up requiring multiple volumes of documents that went through all the proposed actions and alternatives for the development. A project of this scale and magnitude had a very lengthy public comment period to finalize the draft EIS.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the Environmental Council? How would you overcome any possible conflicts of interest?

From past experiences and participation in some community neighborhood meetings, I know that there are always opposing and controversial viewpoints, especially around environmental and community sensitive issues. Architects could be perceived as unfriendly to the environment. However, as architects, we are really trained to be good listeners, look at facts, and find reasonable and sensitive solutions. We are in the position of creating true environmentally sensitive solutions.
