

Dear Chair Fukunaga:

First of all, I sincerely apologize for my tardiness in submitting my written statements regarding nomination to the Stadium Authority GM 810. Following are my answers to the questions posed in your letter of March 21, 2012:

(a) Why do you wish to be a member of the Stadium Authority board?

I believe the State has a great facility in the Aloha Stadium and I am excited for the chance to enhance this facility's potential and beauty. It is my belief that the experience and passion I bring to the Authority will continue to successfully position the Stadium.

(b) How do you perceive the role and responsibilities of a board member of the Stadium Authority board?

The State has a venue that showcases our young athletes' competitive talents. It is the Board's duty to ensure that the facilities necessary for our youth to evolve and compete at the highest level are continually developed and maintained. Working with the different stakeholders, we must position the Stadium financially so that it can meet its operational and growth needs.

(c) Given your understanding of the role and responsibilities of the Stadium Authority, why do you believe that you are qualified to serve as a member of its board? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Stadium Authority board.

I have been the Business Manager and Financial Secretary of IBEW Local Union1357 since March of 2004. Local 1357 is a telecommunications Local and throughout my tenure I have negotiated more than 9 collective bargaining agreements in Hawaii and the Commonwealth of the Northern Mariana Islands. As the principal officer of the Union, I manage a staff of six full-time and part-time employees and am responsible for all aspects of the business and finances of the Union, as well as for servicing our membership and enforcing the CBA's

negotiated between the Union and our members' employers, currently Hawaiian Telcom and IT&E. In addition, I have made it my personal kuleana to actively support our members and the companies that employ them through constant promotion of company services and products, good work ethics on the part of both management and bargaining unit employees, sound financial management, etc. The parallel between the Union and the Stadium Authority board is that the Union's support of the two companies we represent is tied to finances, sales, marketing, operations, IT, logistics, etc., and while the Union and the Stadium Authority may be very different entities, the core business principles are the same. That is where I believe my experience will help me execute the mission and duties of a board member.

(d) What do you hope to accomplish during your term of service?

I believe the bulk of the revenues tied to the Stadium Authority rise and fall on both the swap meet and the University of Hawaii football program. I would like to find a way to better stabilize the liability as economic times and a winning football program have created financial gaps that deter the Authority's mission. I would also like to see if there is potential for enhancing the educational opportunities for all schools throughout the state through the use of Aloha Stadium.

(e) Have you reviewed the Auditor's recent report, "Investigation of the Stadium Authority's Swap Meet Operations"? What are your thoughts on the role of the Stadium Authority board in addressing the Auditor's recommendations?

While I am not intimate with the details of the findings, I believe that oversight is important. My understanding is that the Auditor's findings basically ask that the Authority tighten up on its enforcement of policy in certain areas, which I believe it has done and/or is currently doing. The Auditor did make reference to how the use of the facility may not be in compliance with the requirements under the "deeded lands" provisions; however, I understand that vendors such as the swap meet provide revenues that support the facilities so that the Stadium can operate more efficiently in providing a safe venue for our youth.

(f) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Stadium Authority?

I believe my peers, as well as the employers with whom we have contracts, will tell you that I am a person of utmost integrity. I pride myself on doing the right thing. It is easy to stray in unstable times, but being a God-fearing, principled man helps me to stay the course.

The employers will also tell you that I have a strong passion for what I do. Although faced with many difficulties, I am unrelenting when it comes to holding people accountable for their actions. While there have been many changes with the two companies IBEW Local Union 1357 supports, intimate knowledge of my membership and the industry helps me to better position these companies for success, which in turn properly positions our membership.

Finally, but certainly not least, is the experience I have gained as a Union representative; 5 years as a business agent for IBEW Local Union 1357, as well as the past 8 years as its Business Manager/Financial Secretary. Couple that with my 30 years at Hawaiian Telcom and I feel that my work experience gives me the depth to contribute greatly to the Stadium Authority.

Just one of these traits would truly be a tremendous asset for anyone appointed to this honorable position, but the combination of all three can only be a positive thing for the State and the Stadium Authority.

(g) Name one previous experience that would make you stand out. How would this benefit the Stadium Authority?

Since 2005, I've had to weather some of Hawaiian Telcom's most severe operational issues:

- Neglect of its infrastructure
- Change of Administrations
- Global economic conditions
- Highly competitive industry
- Bankruptcy
- Etc.

The experience of going through these challenges has taught me, and this is one thing that I constantly engage Hawaiian Telcom on, that we should never compromise our ability to provide world-class service to our customers. Many times decisions made may provide temporary financial relief, but in the long run the costs increase exponentially and ultimately the customer suffers. The

maintenance and support of Aloha Stadium should be a long term commitment, as well.

(h) Can you foresee any possible conflicts of interest that could arise during your service on the Stadium Authority board? How would you overcome any possible conflicts of interest?

Current Stadium Manager Scott Chan and I were classmates at Kaiser High School and for a brief time at Willamette University. While there may be an appearance of conflict, I believe that my body of work with the two companies I currently support are a testament to my ability to have personal relationships with peers without it interfering with my work or my business decisions. Business is business and my professional responsibilities take precedence over my personal relationships.
