### NOMINATION TO BOARD OF EDUCATION – KEITH AMEMIYA WRITTEN STATEMENT

Having served an inaugural term on the BOE, what made you decide to re-apply?

It's been a rewarding experience to serve on the BOE for the past year, and it's been a pleasure to serve with my fellow BOE members and to work with Superintendent Matayoshi and her administrative team. Although significant progress has been made, much more work needs to be done, and thus it would probably be in the DOE's (and BOE's) best interest to maintain continuity on the BOE, among other reasons.

What do you feel has been your most significant contribution to the Board in the past year?

Along with my fellow Board members, we've tried to bring stability to the Board and work cohesively together. Additionally, we've tried to work collaboratively with Superintendent Matayoshi and her administrative team to reach the Department's goals and objectives without getting involved in the Department's day-to-day operations.

What priorities do you feel are critical that the Board take up during the course of the year next term? What role do you see yourself playing in addressing these issues?

Although there are many, some of the more noteworthy upcoming Board priorities include: (1) continuing to work collaboratively with Superintendent Matayoshi and her administrative team to improve student achievement statewide; (2) continuing to explore ways to use the DOE's resources as efficiently as possible; (3) increasing student learning times and reducing the administrative burdens of our teachers; (4) continuing to engage stakeholders and the community at large to provide much-needed support in all areas; and (5) continuing to explore public-private partnerships in support of our students, teachers, and staff.

My role would be to continue to work collaboratively with the rest of my BOE colleagues to do what we can to support the Superintendent and her team, including providing the necessary resources to fulfill the DOE's many priorities.

How do you feel as an individual member, and the Board as a whole, can improve stakeholder and community engagement in the formation of education policy?

The Board must continue to engage stakeholders and the community by continuing to: (1) hold community meetings statewide throughout the year, (2) attend forums/meetings held by important interested parties such as the He'e Coalition and the Castle Foundation; and

(3) follow up on suggestions/recommendations made to the Board by stakeholders and the community in general.

Can you foresee any possible conflicts of interests that could arise during your service on the Board of Education? How would you overcome any possible conflicts of interest?

Initially, I was concerned that serving on the BOE would conflict with my current position as Executive Administrator and Secretary of the University of Hawai'i's Board of Regents. However, Governor Abercrombie's staff has researched the issue and has found that I would be able to serve in both capacities if confirmed for the BOE position.

However, if any conflict of interest should arise, I would certainly recuse myself from being involved in the conflict of interest issue.
