the Maui County Healthy Volunteers, Maui AIDS Foundation Board, Board of Parents Inc., and the Board of Directors of the Maui Office of the American Heart Association. She has been a Community Clinic Spanish Interpreter, Red Cross HIV Counseling Trainer, Trainer for drug addiction, and speaks Spanish and Italian.

Ms. Santa Maria has been awarded the Governor's Outstanding Team Award as a member of the Dengue Response Team and honored as Outstanding Young Woman of America. Her professional associations include the National Peace Corps Association, Maui Interpreter Hui, Hawaii Public Health Association, and the Maui Rotary Club, among others.

Ms. Santa Maria earned a Bachelor of Science Degree in Physical Education/Health Education from the University of Texas at Austin, a Master's of Science Degree in Athletic Administration/Adult Education from Texas A&I University, and a Master's Degree in Public Health in Health Education/Environmental Education from the University of Hawaii at Manoa.
