Submitting for consideration and confirmation to the Highway Safety Council, Gubernatorial Nominee, JAN K. YOKOYAMA, for a term to expire December 30, 2016.

Chair English and the members of the Committee, thank you for the opportunity to send in my testimony as I reside on Hawai'i Island.

I want to thank Governor Neil Abercrombie for nominating me. I truly consider this an honor and a privilege to be considered as a member of the Highway Safety Council.

I want to also extend a warm mahalo to everyone that submitted letters of support on my behalf.

I was born and raised in Hilo, Hawaii and have lived there my entire life. What got me interested in highway safety was the amount of traffic crashes occurring in front of my house. In one month alone, there were 15 crashes. My neighbors and I formed a Neighborhood Watch to work on this problem. Along with the Hawaii County Police Department, we analyzed the possible causes and found that the road design was at fault. Our Neighborhood Watch worked tirelessly with our legislators to pressure the County to fix the curve, which it did. Since the redesign, there has been no crashes.

As an active Public Health Nurse, I also worked in the preventive aspects of highway safety, like becoming a child passenger seat technician. I am also a founding member of the North Hawaii Outcome Project Motor Vehicle Crash Reduction Team. I have assisted in writing grants for the Hawaii Police Department to obtain a traffic safety coordinator and for the Department of Public Works to obtain GPS systems for more accurate crash locations. I have participated in the Department of Transportation State Highway Safety Plan Emphasis Area #2 (Impaired Driving).

I am now retired but still active in Hawaii Island highway safety issues. My current focus is underage drinking. I voluntarily manage the Hawai'i County Department of Liquor Control SPF-SIG (Strategic Preventive Framework-State Incentive Grant) grant. I sit as vice-chair of the Department's Liquor Adjudication Board.

The main reason I want to sit on the Highway Safety Council is to give Hawai'i County a voice in determining the needs and solutions to highway safety issues.

In closing, I would like to thank this Committee for the hard work you do for the State of Hawai'i and for giving me the opportunity to submit my testimony. Thank you for considering my nomination.
