### Re: Nomination to Natural Areas Reserve System Commission

Aloha Chairperson Dela Cruz and members of the Senate Committee on Water, Land and Agriculture. I appreciate this opportunity to introduce myself to you and present background for you to consider in relation to my nomination to the Natural Areas Reserve System Commission.

I have been a long time proponent of natural area reserves as they have proven to be an effective way to preserve natural resources worldwide. I appreciate your commitment to our native forests and the role they play in protecting Hawaii's water resources, our economy and our reefs.

As a marine biologist, SCUBA diver and Maui resident I'm familiar with Ahihi Kinau Natural Area Reserve and though my personal and professional relationship with Dale Bonar I became interested in the NAR system. Because Dale Bonar is completing his final term in June, 2012, he encouraged me to apply to replace him on the Commission to represent marine and watershed issues - and the island of Maui.

I first visited Maui in1973, and spent twenty years hiking, SCUBA diving and learning about Maui's unique ecosystems. During that time, I was professor of marine biology, oceanography, and interdisciplinary studies at Saddleback College in Mission Viejo, CA. I lived on board a boat and actively participated in underwater research in California, Hawaii, Australia, Micronesia and elsewhere in the Pacific.

Upon moving to Maui full time in 1995, I became involved in coral reef research and education. In 2007, with encouragement from DAR's former chair, I co-founded and currently chair the Maui Nui Marine Resource Council, a broad based community group whose goals are to protect and renew our coastal resources by addressing both watershed and reef issues.

Since 2008, I have represented Maui on the Hawaiian Islands Humpback Whale Natural Marine Sanctuary Advisory Council; throughout 2011, I actively participated in their management plan review process as chair of their Water Quality Working Group.

In January, 2012, I was invited to participate in the Hawaii-Palau Learning Exchange in Palau, along with DLNR Chairman William Aila and other conservation minded representatives from the main Hawaiian Islands and Samoa. Conservation of resources in Palau has significantly improved their economy by attracting visitors to their thriving coral reefs; I believe the same can happen in Hawaii.

My personal goals are to contribute my knowledge and experience about the marine ecosystem to the protection of Hawaii's natural resources; to promote scientific research and monitoring; and to increase public awareness through education and public outreach. Because preservation of our native forests, upland areas and watersheds is vital to protecting our marine ecosystems, our culture and our economy I would be honored to serve on Hawaii's Natural Area Reserve System commission.
