Mr. Baker is a scholarly expert in Linguistics and will defend his Ph.D. dissertation in May 2012. In addition, he is a loving father of two children both enrolled in Native Hawaiian language immersion education. He is very active in the Hawaiian language community and will bring valuable skills and perspective to the KIRC. I will add that he has a great sense of humor and is committed to working in partnership with the other commissioners to continue its good work.
