Chair Hee, Vice-Chair Shimabukuro and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in support of H.B. 108, H.D. 1, Proposed S.D. 1.

The purpose of this bill is to require licenses for large-scale dog breeding, and regulate the housing, care, handling, record-keeping and treatment of dogs kept by licensed breeders. The bill allows each county to assess, implement and enforce its own licensing system, and establishes civil and criminal penalties for violations.

The Department believes that Sections 2, 4, 5 and 6 of this bill, would work alongside existing laws to prosecute various types of animal cruelty that may stem from large-scale dog breeding, and further believes that this will serve as a much-needed deterrent to those who may be inclined to over-breed or wrongfully breed dogs.

H.B. 108, H.D. 1, Proposed S.D. 1, also proposes to regulate the sale of dogs and cats in a public place; the Department does not take a position as to that section of the bill.

For reasons noted above, we support the passage of H.B. 108, H.D. 1, Proposed S.D. 1. Thank you for this opportunity to testify.

My name is Bob Toyofuku and I am presenting this testimony on behalf of the Hawaiian Humane Society (Society) in general support of HB 108, Proposed SD 1.

The Society supports the provisions contained in Part I of the Proposed SD 1 but suggests various amendments to Sections 1 and 2 on pages 1 to 10.

The Society supports the concept of licensing dog breeders as contained in Part ii of this bill, and has no objection to the counties acting as the licensing body rather than the state department of commerce and consumer affairs. However, the Society is of the opinion that it does not feel that it is the appropriate body to grant the license or to assess the appropriate license fees for dog breeders as indicated on page 13, lines 14 to 17. With regard to any inspections and enforcement of any licensing law for dog breeders, the Society is willing to undertake this task provided that adequate funding is provided by the counties. The Society requests that Section 6 of this bill be amended to provide for sufficient and adequate compensation.

Regarding the provisions in part III of the bill the Society supports the concept that all dogs should have an identification microchip and that the owner be required to acquire appropriate county licensing for the dog.

Dear Members of the Senate Committee on Judiciary and Labor,

The American Kennel Club (AKC) writes to express strong concerns with House Bill 108 H.D.1 S.D.1. We write on behalf of numerous responsible dog owners and breeders in Hawaii, and on behalf of citizens who, in the future, may wish to acquire a dog from a local, responsible breeder. We respectfully ask that you do not advance this measure, which includes language previously amended by other committees in SB2492 and SB2494.

The AKC opposes HB108 for the following reasons:

- This bill contains numerous provisions that are detrimental to the responsible keeping and welfare of dogs.
- The burdensome provisions of this bill would apply to every owner of ten intact dogs over the age of
 four months, even if the owner breeds no litters and sell no puppies. A person who breeds occasional
 litters in the home, or even no litters at all, would inaccurately be considered a "large-scale breeding
 facility" under this measure.
- This bill would prohibit owning more than 30 intact dogs over the age of one year. This provision is unnecessary and overreaching, as dog ownership limits, regardless of reproductive status, are already addressed under local ordinances and zoning codes.
- This bill would allow the seizure and impoundment of dogs based on licensing or recordkeeping violations or the lack of adherence to the aforementioned problematic provisions. Under this bill, dogs could be removed from a comfortable, safe and familiar home setting and caged in a pound that provides far less desirable conditions based solely on paperwork violations, lack of compliance with detrimental care requirements, or arbitrary numerical limits. It is unreasonable to seize dogs unless they are in conditions that pose a real and immediate danger to their health and safety.

A discussion of these and other concerns follows.

HB108 contains numerous provisions that are detrimental to the proper keeping and welfare of dogs. While the intent of the bill – to ensure that dogs are provided regular exercise – is appropriate, the specific provisions are untenable:

 "Constant and unfettered access" to an outdoor exercise area could prove lethal to an aged or ill dog, expose dogs to danger from bad weather and predators, and would prevent a responsible owner from confining dogs indoors in the evenings so that barking and other noises do not create a nuisance.

- Because the definition of "dog breeder" would include responsible owners who maintain their dogs in
 home settings rather than in commercial kennels, a requirement to provide each dog with "constant and
 unfettered access" to an indoor exercise area of sufficient size to meet the requirements of the bill is
 unreasonable.
- Responsible breeders utilize numerous methods to maintain the health and conditioning of their dogs. The
 "one size fits all" provisions of HB108 are punitive to responsible breeders and potentially detrimental to
 the health and safety of dogs. The bill would make it illegal to provide exercise to dogs via regular access
 to turn-out areas (even those encompassing multiple acres), playtime within the home, excursions to dog
 parks, and other breed/age/size appropriate solutions. Only the problematic requirement for "unfettered
 access" to an enclosure 24 hours a day, 365 days a year would be acceptable.
- Under HB108, it would be a violation for a "dog breeder" to utilize a dog crate for temporary confinement
 of a dog, for use in housetraining, and for myriad other standard practices among responsible dog owners.
 For example, the use of crate training for dogs, as described in the Hawaiian Humane Association's
 informational flyers, would be denied dog owners who fall under the provisions of this bill.
- A requirement to provide 12" of headroom above the tallest dog in an enclosure is arbitrary and
 unsupported. Likewise, a restriction that enclosures may be no more than 42" above the floor and a
 restriction on stacking enclosures are also arbitrary and unsupported. A requirement for impervious
 barriers between stacked enclosures is a better alternative.

HB108 provides for unannounced inspections of private residences. As noted previously, HB108 would require "dog breeders," including those who neither breed dogs nor sell puppies, to be licensed as "large-scale breeding facilities" based solely on their ownership of ten or more intact dogs. Dog owners so designated would be subjected to unannounced inspections. This is particularly objectionable given that many dog owners and hobby breeders keep dogs in their private homes and are not rightly regarded as businesses.

HB108 would allow the seizure and impoundment of dogs based solely on licensing or recordkeeping violations or the lack of compliance with problematic care requirements. It is unreasonable to seize dogs from their owners unless they are in conditions that pose a real and immediate danger to their health and safety.

- This bill allows for dogs owned by an unlicensed "dog breeder," or by a person found not in compliance with any provision of the bill (even minor violations appear to be adequate) to be impounded. The lack of a license or a minor violation should not enable the government to seize a citizen's property. This does not benefit the animals and would unnecessarily crowd shelters, increase public expense and euthanasia.
- The threat of impoundment and the fines of up to \$1000 per day for an unlicensed breeder and \$1000 per violation for any violation of the care or recordkeeping requirements are unreasonable.

HB108 contains problematic, vague breeding restrictions. The AKC believes that breeding decisions should be made by a dog owner in consultation with a veterinarian.

- The term "unfit for breeding" is not defined, therefore, it is unclear which conditions might render any
 animal unfit or on what criteria a veterinarian would base their examination. The AKC believes
 veterinarians should base their recommendations on the health and condition of an individual dog, rather
 than on conditions dictated by statute, such as age of breeding or "fitness."
- The bill makes it illegal to breed a dog older than eight years of age. Breeding to or utilizing frozen semen
 from a male dog that exceeds this arbitrary age limits in this bill would be a violation. This would reduce
 breeding options and narrow the available gene pool.

HB108 requires county licensing and biennial fees for "dog breeders" who may infrequently – or never – breed a litter. Further, charging a \$500 biennial license fee to occasional hobby breeders, many of whom may sell very few puppies, is unreasonable. Under this bill certain rights and responsibilities are accorded to county governments. However it is unclear if a county may determine that breeder regulation is unnecessary.

HB108 contains many of the same problematic provisions that were contained in last year's SB1522, of which the Hawaii Office of the Auditor concluded "proposed regulation of dog breeder business is problematic, better options are available." This report additionally indicated:

We found little more than anecdotal evidence for a need to protect the public's health, safety, and welfare from abusive activities of large-scale dog breeders.

-and -

Some requirements detailed in the bill can result in hardships to some breeders as they seek a one-size fits-all solution to the widely diverse needs and characteristics of over 150 dog breeds.

The findings of HB108 indicate that an estimated 30 large-scale dog breeders are in operation in Hawaii. However, this bill imposes regulations, substantial fees and breeder licensing requirements on every owner of ten intact dogs, even if that person produces few or no puppies.

We respectfully urge you to not move HB108 forward, as it is detrimental to welfare and safety of dogs, burdensome to responsible dog owners and breeders, and will limit the options for residents of Hawaii to acquire a dog from a local responsible breeder in the future.

Testimony of Heidi A. Cregor, President of the Kerry Blue Terrier Club of Hawaii, in opposition to H.B. 108.

The stated purpose of this bill is to regulate large scale, profit driven canine breeding operations. My fellow club members, who aren't profit driven canine breeding operations, would be adversely impacted by this bill.

I have previously provided testimony to other committees opposing S.B. 2492 and 2494 and in support of HCR 141. It had appeared that the committees had recognized the infirmities in the previous Senate Bills and were taking appropriate action to limit their broad-brush, overreaching effect and to study further the matter. The current draft of H.B. 108 simply revives the previous Senate Bills.

H.B 108 defines a dog breeder simply by the number of dogs owned without regard to whether or not the owner actually breeds dogs or sells puppies. This numbers only definition results in unnecessary licensing requirements and fees. It triggers space requirements for the housing of the dogs that have no basis in any established standards and further triggers warrantless searches of the owners' homes.

I and my organization, The Kerry Blue Terrier Club of Hawaii, oppose cruelty to animals, including "puppy mills", whose only purpose in life is the production of puppies for profit. These mills are antithetical to everything I and my fellow "dog fanciers" stand for. I abhor these mills and support their being put out of business, yet, that this bill "paints with too broad a brush" and will damage those of us who truly promote the best interests of our dogs and our breeds.

It is well known that the very best puppies for pets, for show, for obedience and other dog related events and competitions come from the small "mom and pop" breeders. We are the people who breed for the sheer love of dogs and improve our breeds, by gradually breeding better, stronger, healthier animals, free of genetic diseases, defects and temperament shortcomings. As hobby breeders we do it for the love of dogs and profit is not our motive. Most of us don't even break even on a litter of puppies, and we do not sell through pet stores. We get our reward when one of our puppies (usually no longer owned by us) goes on to win a Best in Show, or High in Obedience trial, or field trial champion or, simply earns us the congratulations of our peers. The puppy you buy from a hobby breeder, has had hours of individual attention lavished upon him. We stand behind our puppies and most provide some type of guarantee to the buyer. If the puppy is not show quality, or more accurately, not of a quality to genetically promote the breed, we have the option under the rules of the American Kennel Club, to sell the puppy with a limited (cannot be bred) registration.

Most of us are very small scale, often going years between litters and only breeding when the time is right in all respects. I myself have had very few litters, yet I am considered a breeder by my peers. Even for small scale hobby breeders like me, the provisions of this bill can be too restrictive and oppressive. Having a **number limit**, like ten intact dogs may sound like a lot - but in order to be eligible to enter a dog show, the dogs must be intact. It should be no surprise that we don't discard our older dogs as they retire from the show ring. Many of us have several well-loved retired dogs enjoying our backyards. So, a litter of puppies can really run the numbers up, especially in some breeds that have large litters. Yes, most pet dogs are gone by four months of age, but a good responsible breeder will often keep better show prospect puppies much longer to see how they develop before selling them. And, yes, these puppies continue to receive the same

I view the amendments to the BILL as underhanded, sneaky, un-American, auwae...No Aloha Spirit, crooked legislation...how rude...is this our Hawaii government at work?? How many more bills are floating around that I mimic SB2492, SB2494, HB108?? Mind boggling to say the least...is this all that Senator Clayton Hee has to do with his time?? Just trying to keep up with these issues is like catching fish by hand, grab one, and it slips away, grab another and it slips away...

I am Vice President of the Hilo Obedience Training Club, and AKC affiliated club which conducts three sessions of dog training classes throughout the year offered to the general public. Our organization promotes responsible dog ownership and sportmenship, as well as teaching dog owners the benefits of having a well trained, well mannered, and sociable dog. Our classes are continually in demand, and an asset to the our community and State. We have proudly instructed purebred and mix breed performance titlist in obedience and rally venues. Our classes are open to ALL breed of dogs, including the All American Dogs...the mix breeds.

I am also a member in good standing with the Orchid Island Dog Fanciers Club, Orchid Isle Dog Agility, Hawaii Herding Dog Association, and Shetland Sheepdog Club of Hawaii. I am an AKC Certified Canine Good Citizen Instructor and Evaluator for the American Kennel Club. You can be assured that Breed Clubs and Performance Clubs in Hawaii and throughout the United States promote responsible dog ownership and breeding of dogs

As a Purebred Fancier and Breeder, I maintain and treat my Shetland Sheepdogs better than some families treat their human children, elderly, and relatives. I spend a small fortune in the maintenance, medical care, and health of my dogs. Careful consideration is given to my breeding program as I only breed to improve my Shetland Sheepdog line. In my 26 years of dog ownership, I have had only three litters to date. My three litters were carefully planned, with selection of sire and dam, completion of pre-testing of genetic conditions, quality maintenance of nutrition and medical care throughout pregnancy, whelping and weaning, and completion of puppy examinations and shots. Puppies from those breedings which were sold were ~ AKC Registered, AKC-CAR mircochipped, Health Certified by my Vet, Health and Shot records provided to buyers, and with CONTRACTS that required Non-Conformation Show pups to be spayed and/or nuetered by 6-8 mos of age, genetic health guarantees for replacement, and return of the dog to me, as the breeder, throughout the LIFE of the dog. In my contracts, I restricted new owners from breeding any Non-Conformation Show Dogs by LIMITED AKC Registration,. I further restricted new owners from abandoning the dogs, re-selling on Craigslist or Kajiki or classified ads, and I RESTRICTED THEM FROM TURNING THE DOGS INTO THE HAWAIIAN HUMANE SOCIETY, or any other rescue

organization. My contract requires the new owner to RETURN the dog to me if at anytime IN THE LIFE OF THE DOG, the new owner cannot care for and/or maintain the dog.

I required all new owners to have a fenced yard and/or fenced exercise enclosure for the benefit and safety of the dog and the community. I have never had any complaints or disgruntled new owners. I carefully evaluate new potential homes to assure that they meet my expectations for the care of my puppies. The new owner must be financially able to care for my puppies. I do not sell to people who cannot afford to keep a dog up to my expectations. Of my three breedings, 12 puppies total, in 26 years, only one puppy returned to me due to the new owner's change in work schedule, taking her out-of-state. I know where the 12 puppies are, and I maintain contact with the owners periodically.

My Conformation Show Puppy potentials are sold on an unlimited bases (not/spayed or neutered), as these pups are the best pups of the breeding in the litter and will perpetuate the AKC Purebreed standard for my breed, the Shetland Sheepdog.

Can the HUMANE SOCIETY match my standards, which is basically the standards that Purebreed Dog Fanciers throughout the State live by...I doubt that they do. When I visited the Hawaii Humane Society in Keaau in February 2012, I witnessed that they had multiple dogs in all kennels, and they did not have unrestricted access to a play yard. Their standards of housing were far inferior to my dog kennels and play yards...the dogs were not able to come into a house and lounge on the sofa as my dogs do...they did not have toys, blankets, or pillows like my dogs do. A huge double standard contained in HB108 Amended.

I am not opposed to LIMITED control of dog breeding and sales, as I have rescued dogs that irresponsible individuals cast aside and abandoned. I cared for the recues WITHOUT THE HELP OF THE HAWAII HUMANE SOCIETY, and I re-homed those rescues with loving families...I did not euthanize them as the Humane Society would have done.

I believe that HB 108 AMENDED is overly restrictive and unreasonable. It is an attack on all due to the irresponsibility of a few. It is a double standard, giving exception to the Humane Society, Veterinarians, Rescue Groups, etc. while oppressing the general public dog fanciers. It is being pushed forward by an organization that is NOT local, with lobby interest, with questionable non-profit status, an organization that begs for donations nationally on television, but also an organization that slaughters millions of dogs annually under the umbrella of being HUMANE!! HUMANE would exemplify passing on the millions of dollars they generate annually from the general public and funneling that money back to the local shelters. Instead, the donations are used to fatten the cows grazing in the board room and executive offices of the Humane Society. I challenge Hawaii legislatures not to be swayed by the Humane Society lobbyist and their puppet Clayton Hee, stand up against legislation that does more harm than good. Oppose HB108 AMENDED, and instead work on a bill that will effectively control the

perpetrators of cruelty and abuse in an appropriate and reasonable way, without exterminating the dog fancier.

To restrict our breedings of Purebred dogs as allowed in HB108 AMENDED will ultimately kill the sport of Conformation and Show Dogs in Hawaii. Only intact Dogs and Bitches are allowed to be in the Conforantion Ring according to AKC Rules and Proceedures...Please do not destroy the Show Dog Sport in Hawaii. PLEASE DO NOT ALLOW THE HUMANE SOCIETY TO DICTATE THAT Hawaii become an anti-dog State...where is the ALOHA in that reality. Stop this bill as it is written and submit a revision that is reasonable and that promotes responsible dog ownership as well as Purebreed Breeding Programs.. Check out what the American Kennel Club, Eukanuba and Iams Company, and Purina Company promotes as responsible breeding programs.

Importation of dogs to the Hawaiian Islands is limited and strictly regulated. HB108 AMENDED calls into question where citizens of Hawaii will obtain future generations of Purebred dogs and pets.

I OPPOSE HB 108 SD1.

I have previously submitted testimony OPPOSED to SB 2492 and SB 2494.

I have previously submitted testimony in SUPPORT of HCR 141.

I am a lifelong resident of Hawaii and registered voter.

I, and my family, have always had dogs as companions, both pure-bred and poi dogs. I am a member of the Kerry Blue Terrier Club of Hawaii, a founding member of Terriers In Paradise and have belonged to the United states Kerry Blue Terrier Club and The American Working Terrier Association as well as the local Obedience Training Club of Hawaii and the Leeward Training Club. I have been involved through my dog club in dog rescues and placements and have adopted a rescue dog myself. I currently have one dog in my immediate family.

I am against "puppy mills" and dog fighting (HB 108-original bill); I am for ethical treatment of animals, as is everyone I am associated with in my dog community and my larger community.

However, there are a few people who do mistreat animals and I support suitable legislation to address this, especially the recent " puppy mill" in Waimanalo and their ability to manipulate the system and avoid accountability through corporate procedure.

The proposed bills, SB 2492, SB 2494 and SB 2504, now brought forth as HB 108 and amendment HB 108 SD1, do not deal with the problems associated with that "puppy mill". Instead, through the amendment, and like the originally numbered bills, they penalize, may even criminalize, regular ordinary dog folks and ethical dog businesses which is like making anyone of us who walks into our local 7-11 a criminal because an armed robber has gone into the 7-11 and robbed them and might do so in the future.

We ordinary dog people and dog businesses are not villains or criminals, not mistreating animals, and these bills would lump us into the same category as those who are running " puppy mills".

This attempt to bring back SB 2492, SB 2494 and SB 2504 as HB 108 and the amendment HB 108 SD1 does not stop "puppy mills" like the recent Waimanalo operation and does not punish the miscreants. Not only does it not address how to stop the "puppymills" from manipulating the system, it retains the egregious problems with the original numbered bills in that the focus is on the ordinary local dog person who may have a litter of puppies and the ethical dog businesses and not the unethical people hiding behind corporate legal

procedures. Though opinions may differ on how to handle the "puppy mill" problem, it is a fact that all dog businesses, all dog owners, all dog breeders are not "puppy mills" and treating each of these seperate entities as if they are one and the same defies common sense.

The HCR141 proposal which requests the director of DCCA to convene a task force composed of our local professionals to develope suitable legislation for Hawaii, which would hold the wrongdoers accountable while protecting our animals, our local people and local businesses, is the reasonable step to provide suitable legislation on dog breeding and I will urge support of that type of prudent act.

We here in Hawaii do know what we need to do for our community. I urge you to listen to your local dog clubs and ordinary dog loving constituents. I am also secretary of The Boxer Club of Hawaii, which helps educate the public on responsible breeding.

Although I am not opposed to licensing, I think we need breeder buy-in before proposing a licensing program. I think when breeders, the humane society and pet stores work together we accomplish more for animals.

I know that SB 2492 is now at a place where many have come to consensus on. I am not personally opposed to breeders having a license, but the enforcement process must be transparent to responsible breeders.

I completely support part three of the bill and ask you please keep that portion of the bill. Right now, this bill is the only way I know of protecting animals at pet stores. Hawaii currently has no laws protecting animals sold through the pet trade nor do we prohibit the sale of animals off the side of the road. Roadside sales are unsanitary and a stain on a caring community.
