The Regulated Industries Complaints Office ("RICO") of the Department of Commerce and Consumer Affairs appreciates the opportunity to testify on House Bill No. 1295 H.D.2, Relating To Business. My name is Daria Loy-Goto, Acting Complaints and Enforcement Officer for RICO and member of the Unlicensed

Contractor Law Enforcement Task Force ("Task Force"). RICO offers the following testimony in support of the bill.

Pursuant to House Concurrent Resolution 286 H.D.1, the Task Force met over several months to develop an enforcement strategy among the various civil, administrative, and criminal enforcement agencies concerning unlicensed contracting. To further this goal, the Task Force created a subgroup called the Law Enforcement Small Working Group, consisting of representatives from RICO, the Office of the Attorney General Criminal Division, and the Offices of the Prosecuting Attorney for the counties. House Bill No. 1295 H.D.2 is the result of that group's collaborative efforts.

The group found that, although unlicensed activity is a misdemeanor under current law, enforcement would be enhanced if there were specific omnibus sections in the Penal Code that establish criminal offenses for unlicensed contracting activity, habitual unlicensed contracting activity, and unlicensed contractor fraud. The bill also amends §436B-27, Hawaii Revised Statutes, to conform to the new language in the Penal Code.

Instances of unlicensed contracting range from persons with experience who ultimately work toward and obtain licensure, to persons with little or no experience who most likely would not qualify for licensure, to those with little or no intention to complete work for monies received. House Bill No. 1295 H.D.2 is intended to address egregious unlicensed contracting activity, including chronic and repeat

unlicensed contracting activity. The bill is not intended to cover inadvertent oversights by licensees in complying with the licensing law.

Chair Keith-Agaran, Chair Herkes, Vice-Chair Rhoads, Vice-Chair Yamane, members of the House Committee on Judiciary and members of the House Committee on Consumer Protection & Commerce, the Department of the Prosecuting Attorney, City and County of Honolulu, submits the following testimony in support of House Bill 1295, House Draft 2.

House Concurrent Resolution 286, House Draft 1, requested that the Director of the Department of Commerce and Consumer Affairs (DCCA) establish a task force to develop a collaborative enforcement strategy concerning unlicensed contractors among civil, criminal, and administrative enforcement agencies. The task force was also requested to evaluate existing laws and propose new laws or revisions to existing laws that apply to unlicensed contractors, where appropriate, to facilitate better enforcement.

House Concurrent Resolution 286, House Draft 1, also requested that the task force report its findings and recommendations and any proposed legislation to the Legislature no later than twenty days prior to the 2012 regular session.

In December 2011, the task force submitted a report to the Legislature. The task force also submitted proposed legislation. H.B. 1295, H.D. 2 is the present version of the proposed new legislation recommended by the task force.

The Department of the Prosecuting Attorney was a member of the task force. The Department supports H.B. 1295, H.D. 2. The purpose of H.B. 1295, H.D. 2 is to create the new offenses of: Unlicensed Contracting Activity, as a misdemeanor; Habitual Unlicensed Contracting Activity, as a class C felony; and Unlicensed Contractor Fraud, as a class A, B or C felony. The Department agrees with the other members of the task force that the language of HB 1295, H.D. 2 is appropriate and necessary to address the problem of unlicensed contractor activity, and in particular, unlicensed contractor fraud.

For these reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu supports H.B. 1295, H.D. 2. Thank for you the opportunity to testify on this matter.

Good morning Chairs Keith-Agaran and Herkes, Vice-Chairs Rhoads and Yamane, and members of the Committees:

My name is Gladys Marrone, Government Relations Director for the Building Industry Association of Hawaii (BIA-Hawaii). Chartered in 1955, BIA-Hawaii is a professional trade organization affiliated with the National Association of Home Builders, representing the building industry and its associates. BIA-Hawaii takes a leadership role in unifying and promoting the interests of the industry to enhance the quality of life for the people of Hawaii.

BIA-Hawaii **supports** H.B. 1295 HD2, which would: 1) Establish unlicensed contracting activity as a misdemeanor offense; 2) Establish habitual unlicensed contracting activity and unlicensed contractor fraud as felonies; and 3) Require that each day of unlicensed contracting activity be deemed a separate offense.

H.B. 1295 HD2 is a result of findings and proposed legislation by the Unlicensed Contractor Law Enforcement Task Force (UCLETF), which was created pursuant to H.C.R. 286 HD1 (2011). This resolution requested that the Director of the Department of Commerce and Consumer Affairs establish a task force to develop a collaborative enforcement strategy concerning unlicensed contractors among civil, criminal, and administrative enforcement agencies. The task force was also requested to evaluate existing laws and propose new laws or revisions to existing laws that apply to unlicensed contractors, where appropriate, in order to facilitate better enforcement.

The UCLETF included a working group comprised of prosecuting attorneys from the various Counties and the Office of the Attorney General. The working group suggested a new, omnibus law that would be housed in the penal code, assisting criminal law enforcement officers.

The bill's habitual unlicensed contracting activity provision is to create a new felony provision that could be used to prosecute egregious and otherwise undeterred conduct. The bill's new fraud provision is aimed at prosecuting serious, fraudulent unlicensed contracting schemes, especially against our elderly.

The construction industry had concerns that contractors whose license temporarily lapsed due to late insurance filings, etc., may be prosecuted under this measure. However, the working group discussed this concern, with the Prosecuting Attorney's office, and it is clear that prosecution of inadvertent lapses in licensure is not the intent of this bill. The bill is intended to address habitual unlicensed activity.

Unlicensed contractors cost the State and its taxpayers millions of dollars in tax revenue because these contractors receive or pay wages in cash, thereby avoiding unemployment, payroll, and personal tax obligations. Unlicensed contractors often operate without regard to worker and workplace safety requirements. There are unlicensed contractors who continue to engage in illegal contracting despite prior judgments and injunctions. Furthermore, unlicensed contractors place consumers at serious risk of faulty construction and financial harm, without any recourse. Finally, unlicensed contractors adversely impact the legitimate and licensed business operations within the contracting industry.

For the foregoing reasons, BIA-Hawaii supports H.B. 1295 HD2.

Chair Keith-Agaran and Members of the House Committee on Judiciary:

I am Gerald Yamada, President of GW Construction & Yamada Paint Contracting on the Big Island of Hawaii. We are a family company located in the Shipman Business Park in Keaau. GW Construction and Yamada Paint have been in business here for apprx 25 years.

I support HB 1295. Unlicensed activity here is at an all time high. Unlicensed contractors blatantly do all types of work here. We estimate that apprx 80 percent of home construction here is being done by unlicensed contractors. A lot of the construction workers believe they are better off collecting unemployment and being paid cash by unlicensed contractors. This is unfair to licensed contractors who must work four times as hard to make an honest living.

A licensed contractor must meet rigorous tests of the Contractors License Board, such as having the required training and experience in the trade, financial standing, and knowledge of state laws. The licensed contractor must have workers compensation, TDI and liability insurance. Alicensed contractor must pay taxes. Hiring a licensed contractor provides certain remedies to the consumer if a licensed contractor has violated the law. There are no remedies for the consumer if they hired an unlicensed builder.

There is no way for a legitimate contractor to compete against an unlicensed one. Many homeowners and property managers use unlicensed contractors to save money. We all want to save money but let's do it properly. The State is losing out on millions of dollars due to unpaid taxes.

HB1295 would help to significantly curb unlicensed activity.

I ask for your support in passing HB 1295.

Dear Chairs Keith-Agaran and Herkes, Vice Chairs Rhoads and Yamane and Members:

The General Contractors Association (GCA) is an organization comprised of over six hundred (600) general contractors, subcontractors, and construction related firms. The GCA was established in 1932 and is celebrating its 80th anniversary this year; GCA remains the largest construction association in the State of Hawaii. GCA is in **support of the intent** of H.B. 1295, HD 2 Relating to Business.

This bill amends Section 708, Hawaii Revised Statues (HRS) to address unlicensed construction activity by creating a new Chapter establishing unlicensed contracting activity as a criminal offense. The bill provides that individuals found guilty of repeated violations or fraudulent unlicensed construction activity may be charged as a felony offense. The bill also establishes a schedule of fines for violations of the section.

The GCA appreciates the work of the Unlicensed Contractor Law Enforcement Task Force and their proposed legislation. GCA supports the rationale and need for added disincentives to curtail repeated violations of Chapter 444, HRS that require the licensing of all contractors doing work in Hawaii. However, the statutes should include safeguards to ensure that only those individuals who were never licensed under Chapter 444, HRS are considered unlicensed contractors. Licensed contractors who are found to be working out of scope or those with lapsed licenses due to failure to timely file for renewal or those whose licenses are in the process of being transferred should not be considered as unlicensed.

The Contractor's Licensing Board should continue to maintain jurisdiction over issues relating to proper licensure and transfer of licenses. The GCA supports the intent of H.B. 1295, HD 2 and recommends its passage by the Committee.
