#### Re: HB1295HD3 RELATING TO BUSINESS

The Department of Labor and Industrial Relations (DLIR) <u>strongly supports</u> HB1295HD3 RELATING TO BUSINESS, which establishes criminal sanctions for unlicensed contracting activity. DLIR participated in the Unlicensed Contractor Law Enforcement Task Force pursuant to HCR286HD1 (SLH, 2011). DLIR believes a nexus exists between unlicensed contractor activity and attempts to avoid labor law regulation and enforcement.

DLIR joined in the Small Working Group on Information Sharing and developed several Memorandums of Agreement with the other departments as part of the overall effort to reduce unlicensed contracting and the avoidance of labor laws. HB1295HD3 is a product of the Small Working Group on Enforcement. The proposal establishes criminal offenses for unlicensed contractor activity, including chronic and repeat unlicensed contracting activity, and unlicensed fraud. The proposal excludes penal offenses for a first instance involving the inadvertent failure of a licensee to renew a previously existing license.

DLIR believes establishing criminal offenses for unlicensed contracting will serve as both an effective deterrent to unlicensed contracting activity and attempts to circumvent labor laws. Therefore, the department strongly supports this proposal.

The Regulated Industries Complaints Office ("RICO") of the Department of Commerce and Consumer Affairs appreciates the opportunity to testify on House Bill No. 1295 H.D.3, Relating To Business. My name is Daria Loy-Goto, Acting Complaints and Enforcement Officer for RICO and member of the Unlicensed

Contractor Law Enforcement Task Force ("Task Force"). RICO offers the following testimony in support of the bill.

Pursuant to House Concurrent Resolution 286 H.D.1, the Task Force met over several months to develop an enforcement strategy among the various civil, administrative, and criminal enforcement agencies concerning unlicensed contracting. To further this goal, the Task Force created a subgroup called the Law Enforcement Small Working Group, consisting of representatives from RICO, the Office of the Attorney General Criminal Division, and the Offices of the Prosecuting Attorney for the counties. House Bill No. 1295 H.D.3 is the result of that group's collaborative efforts.

The group found that, although unlicensed activity is a misdemeanor under current law, enforcement would be enhanced if there were specific omnibus sections in the Penal Code that establish criminal offenses for unlicensed contracting activity, habitual unlicensed contracting activity, and unlicensed contractor fraud. The bill also amends §436B-27, Hawaii Revised Statutes, to conform to the new language in the Penal Code.

Instances of unlicensed contracting range from persons with experience who ultimately work toward and obtain licensure, to persons with little or no experience who most likely would not qualify for licensure, to those with little or no intention to complete work for monies received. House Bill No. 1295 H.D.3 is intended to address egregious unlicensed contracting activity, including chronic and repeat

unlicensed contracting activity. The bill is not intended to cover inadvertent oversights by licensees in complying with the licensing law.

RICO notes, however, that the bill has a defective effective date and respectfully requests that the defective date be amended to July 1, 2012. There is no Senate companion measure.

Thank you for this opportunity to testify on House Bill No. 1295 H.D.3. I will be happy to answer any questions that the members of the Committees may have.

Chair Hee, Chair Baker, Vice-Chair Shimabukuro, Vice-Chair Taniguchi, members of the Senate Committee on Judiciary and Labor, and members of the Senate Committee on Commerce and Consumer Protection, the Department of the Prosecuting Attorney, City and County of Honolulu, submits the following testimony in support of House Bill 1295, House Draft 3.

House Concurrent Resolution 286, House Draft 1 (2011), requested that the Director of the Department of Commerce and Consumer Affairs establish a task force among civil, criminal, and administrative enforcement agencies, to develop a collaborative enforcement strategy to address unlicensed contractors. The task force was also asked to evaluate existing laws, and propose new laws or revisions to existing laws, regarding unlicensed contractors, to better facilitate enforcement.

In December 2011, the task force submitted a report and proposed legislation to the Legislature. H.B. 1295, H.D. 3, is the present version of the proposed legislation recommended by the task force.

The Department of the Prosecuting Attorney was a member of the task force, and supports H.B. 1295, H.D. 3. The purpose of H.B. 1295, H.D. 3, is to create the new offenses of: Unlicensed Contracting Activity, as a misdemeanor; Habitual Unlicensed Contracting Activity,

as a class C felony; and Unlicensed Contractor Fraud, as a class A, B or C felony. The Department agrees with the other members of the task force that the language of HB 1295, H.D. 3, is appropriate and necessary to address the problem of unlicensed contractor activity, and in particular, unlicensed contractor fraud.

For these reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu supports H.B. 1295, H.D. 3. Thank for you the opportunity to testify on this matter.

William C. Loeffler Construction, Inc. strongly supports H.B. 1295 HD3.

Through the years we have witnessed the illegal unlicensed activity of people that have continued to work despite their prior judgments. Their penalties definitely need to have higher consequences in order to make an impact.

Unlicensed construction activity is often targeted to the elderly and this is criminal all in itself. Just this week we had an officer come in to get a quote on what an elderly lady had thought she was getting for a newly resurfaced driveway from an unlicensed person. She was charged and PAID 7 times the amount that would be acceptable in our eyes and she did not get the end product. In the past, we have had to go in and remove and replace work done by unlicensed activity at still much less than the elderly were charged and paid to the illegal contractor. They are often too embarrassed to press charges with the police.

The other obvious reasons: guarantee of work, quality of materials and workmanship, having insurances, paying of taxes, safety of both the customer and themselves, and jeopardizing the legitimate contractors play strongly for support of this bill too.

Again, we strongly support this H.B. 1295 HD3.

Maui Contractors Association strongly supports HB1295 HD3, Relating to Business. It will establish unlicensed contracting activity as a misdemeanor offense, establish habitual unlicensed contracting activity and unlicensed contractor fraud as felonies requires that each day of unlicensed contracting activity be considered a separate offense and specifies that a licensee in a first instance involving the inadvertent failure of such licensee to renew a previously existing license shall not be penalized under the newly created offenses.
