In this world of war, famine and poverty dancing may seem irreverent, but the freedom to move my body is a human right that should not be written off as trivial.

After getting dancing on the agenda of the Maui County Liquor Commission three times all we have been told is it is illegal to "move the body, especially the feet, in rhythm, ordinarily to music"' off the dance floor. Both our court cases were thrown out because we did not have jurisdiction to question the rules of the liquor commission in court. It is administrative law and as a citizen who does not have a licensee to serve alcohol my voice can not be heard. A few days before our last court appearance we went to the Maui News to get media coverage and the (x)editor Ed Tanji told us " when the liquor commission decides something it's already done, there is nothing you can do about it." He sent no press, but did do the LC's press release afterwards stating their victory.

"Can you do the watusi?" No. I can live with that and go do it on the dance floor. "Can you tape your toe?" No. Then their is something wrong here and it will take legislation to address it. At the last liquor Commission meeting we went to, when Lance Collins asked for a Declaratory Ruling on our behalf, they refused to define §08-101-23 Special conditions a and b for us and voted unanimously to never speak of it again.

Is that democracy? I urge you to support HB 1339. Flailing about and disorderly conduct should be limited to a dance floor, but we all have the right to move our bodies moderately.
