HOUSE BILL NO. 1524 HOUSE DRAFT 2 RELATING TO AGRICULTURE

Chairperson Nishihara and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 1524 HD2, which proposes to require those sentenced for agricultural theft to provide restitution to the victim for the stolen agricultural product or commodity and cost for replanting the agricultural product or commodity. The bill also proposes that failure to maintain required ownership certificates while in possession of agricultural commodities constitutes an offense of theft in the second degree. The department strongly supports this bill.

The reported losses, as documented by a statewide survey of farmers conducted by the Department of Agriculture, USDA, and the Hawaii Farm Bureau, totaled millions of dollars. The proposed amendment allows for the prosecutors to develop stronger legal cases relating to agricultural theft and repayment to the farmers for stolen property and replanting.

We are a local kamaaina-family owned land management company that is engaged in Agriculture and Commercial/Industrial development and leasing. We currently lease lands to over 130 individually growers at W.H. Shipman, Ltd.

W. H. Shipman, Ltd., and their growers provide strong support to HB 1524, HD2, Relating to Agricultural Theft. This will require those sentenced for agricultural theft to provide restitution to the victim the value of the stolen agricultural product or commodity, or the cost of replanting these products or commodities.

This Bill will also include in the offense of theft in the second degree the failure to maintain required certificates while in possession of agricultural commodities. The majority of stolen products or commodities are often sold to vendors at the local farmers markets on the islands. In order to restrain people from selling stolen agricultural products or commodities, a certificate of ownership or written proof of ownership shall be required.

Aloha Chair Nishihara, Vice Chair Kahele, and Members of the Committee,

I am Janet Ashman, testifying on behalf of the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

We support this bill that would require restitution to a farmer from the convicted thief who has stolen the farmer's products. Unfortunately, theft from farms has become rampant in the islands. There is no way that a farmer can guard every inch of his property every minute of the day and night. No farmer can afford to hire security guards to do this and he shouldn't have to. Our police departments are trying to help but they certainly don't have the staff to be everywhere at all times. Thieves have become so brazen that they take orders from farmers' markets and fill them by stealing fruits and vegetables right from farmers' fields the night before their promised delivery. This should not be allowed to continue.

We also support other sections of the bill and we respectfully request that you consider merging some of the clarifying language from SB 2914 with this bill to have a more complete enforcement tool for police and prosecutors.

We have had many plant thefts and I would hope that this bill will also cover private residences and commercial property in addition to agriculture. There had been so many plant thefts in Kailua that we held a community meeting on May 26, 2010. Twenty seven people attended including our local police. There have been thefts of plants pulled up directly out of the ground in people's yards, a very large wooden planter taken from Baci Bistro, and hanging plants from many businesses. Also, red ti plants have been stolen from the Kailua Post Office on federal property. I live in Meridian East on Aulike St., Kailua when we had a landscaper plant our front area, he suggested that we fence the area for at least six months until the plant roots were firmly in the ground. We did fence the area at extra expense. This was all because of the plant theft issue in our area.

Yes, please pass 1524 HD2. I would like to see the enforcement date much sooner than 2020. Thank you very much.
