My name is Deanne Tully and my husband is Scott March; we are residents of the Puuanahulu community here on the Big Island of Hawaii. We are also a customer/member of the nonprofit water company, Napu'u Water Inc. (NWI), which provides safe drinking water to this community. As you may know, this community is rather isolated and we do not have access to County water. NWI has been providing us with safe, clean drinking water on a reliable basis for a number of years now. NWI is a simple nonprofit organization whose only purpose is to provide this critical water to the members of our community. Our Board of Directors consists entirely of volunteers who generously give their time to manage NWI for the benefit of all us who live here. Currently, NWI is obligated to pay GET tax just like a for-profit company, which is simply not fair or equitable. I don't begin to understand why that is, the Tax Code is simply too complicated to me. However, Representative Evans has introduced HB1705, a tax compliance bill that will rectify this unfair situation and treat NWI just like every other nonprofit. I wholeheartedly support this bill and urge you and your colleagues to support it as well. It will correct a fundamental unfairness and allow the state to tax us like a nonprofit, which is exactly what we are. We are good people in this community - we work hard, pay our taxes, help our neighbors - and we humbly and respectfully ask you to do the right thing and pass this bill.

SUBJECT: INCOME, GENERAL EXCISE, Exempt potable water

BILL NUMBER: HB 1705, HD-1

INTRODUCED BY: House Committee on Finance

STAFF COMMENTS: Amends HRS section 235-2.3(b) to provide that IRC section 501(c)(12) (with respect to exempt organizations) shall be operable for companies that provide potable water to communities that lack any access to public utility water services and shall not be subject to state income taxation.

Amends HRS section 237-23 (a) to provide that companies that provide potable water to communities that lack any access to public utility water services and are exempt under IRC section 501(c)(12) shall not be subject to the general excise tax.

EFFECTIVE DATE: July 1, 2030; applicable to tax years beginning after December 31, 2011

STAFF COMMENTS: Under current law, IRC 501(c) (12) organizations, while exempt from federal income taxation, are taxable under the state income tax provisions.

While this measure would exempt from state income and general excise taxation an IRC 501(c)(12) organization that provides potable water to communities that lack any access to public water utility services, it would provide preferential tax treatment to a very select group of taxpayers. From the standpoint of equity, such preferential treatment should be granted to all IRC 501(c)(12) organizations with a sunset date of one year to allow the legislature to determine the effects and outcomes of the exemption and whether it should be continued or repealed. While this measure would make the exemptions permanent, a sunset date could be added and the exemptions could be examined to determine whether the exemptions are achieving the desired goal. At the very least, the department of taxation should be tasked with explaining whether or not such organizations should or should not be recognized as being exempt for state tax purposes.

Consideration should be given to drafting an exemption for this entity other than basing it on the fact that it is recognized under federal Code 501(c)(12). Such specific exemptions already litter both the income tax and general excise tax chapters. By specifically describing the nature of this, its composition, the public purpose that it serves, and the fact that it is exempt from federal liabilities would then insure that it does not set a precedent for other (c)(12) organizations to ask for similar treatment.

I have been a resident of Pu'u Anahulu for 38 years and am the president of the Board of Directors of Napu'u Water Inc. (NWI). I strongly support HB1705 (a tax compliance bill). Our non-proft community water system, NWI, has provided potable water to the entire residential community of Pu'u Ananhulu and Pu'u Wa'awa'a since NWI purchased the water system from F. Newell Bohnett in 2006. There is no other potable water source available within the community for the residents of this area. The cost of our water for the residents is extremely high because the water is pumped from the source at 2500 feet below ground level. This cost is a serious financial burden for many of our residents, many of whom have lived here for generations. NWI also supplies water to the cattle that graze on the pastures leased from the Dept. of Land and Natural Resources (DLNR). These cattle are a management tool to mitigate the severe fire hazard from thousands of acres of fountain grass surrounding our residential communities and while DLNR and its partners slowly restore the invaluable native dryland forest at Pu'u Wa'awa'a. I respectfully request favorable consideration of HB1705 to alleviate some of the financial burden to our members.
