ON HOUSE BILL NO. 1755

RELATING TO VOTER REGISTRATION

January 24, 2012

Chair Keith-Agaran and members of the House Committee on Judiciary, thank you for the opportunity to testify in support of House Bill No. 1755. The purpose of this bill is to provide for online voter registration.

In order to provide another opportunity for the registration of eligible voters, the present bill authorizes applicants to register electronically. This will require the creation of an online voter registration system. Given the technological issues associated with planning and designing such a system, this bill appropriates \$500,000 for fiscal year 2012-2013 for that purpose. The possible need for additional funding for the implementation of the system will be addressed after the planning and design stage.

Additionally, the bill makes minor housekeeping changes to update our voter registration laws to conform to online voter registration, and to remove references obsolete processes and technologies.

Finally, the bill removes the requirement to post a list of all registered voters in each precinct at the polling place. Voters have expressed privacy concerns in the past as the list is required to include the voter's residence address, unless a voter has gone through the process of obtaining confidential status to have the information removed.

Chair Keith-Agaran, Vice Chair Rhoads, and Committee Members:

Common Cause Hawaii supports HB1755. This bill allows for the establishment of online voter registration, and appropriates funds to create and implement the system.

We support this effort to modernize voter registration for the 21st century and reduce barriers to voting. Hawaii has been consistently at or near the bottom of all 50 states in voter turnout, and every effort should be made to encourage eligible citizens to participate. The numbers from the 2010 General Election show that there are 930,624 eligible voters in Hawaii, but only 690,748 registered voters. This leaves an estimated 239,876 potential voters -- 26% of those eligible -- who were not registered at the time of the 2010 General Election. Online voter registration can make participation in our democratic process more accessible and convenient.

Online voter registration can also provide greater accuracy in the voter rolls and save significant money in the long term, by streamlining the process and reducing the burden of data entry. A study by the Pew Center on the States showed that in Arizona, it costs an average of three cents to process an online application compared to an average of 83 cents per paper application; in Washington, the state saves 25 cents per online application and counties save between 50 cents and \$2.00 per online application compared to paper forms.ⁱⁱ

Two questions and suggestions:

• In Section 1 of the bill, it reads: "the county clerk may permit...." Does the bill require the establishment of an online voter registration system, or only permit it? We would ask the legislature to work towards requiring an online voter registration system for all eligible voters throughout Hawaii as soon as possible.

• In Section 5 of the bill, it provides funds in FY 2012-2013 for the planning and design of the system. By what date would the system be completed and ready for use by the new prospective voters? We would urge the legislature to ensure the system can be ready for use by the 2014 elections.

Comments:

HB 1755 will encourage more people to exercise their franchise to vote. This measure is particularly important at a time when other states are moving in the opposite direction and enacting laws that discourage, deter and, in some cases, deprive citizens their right to vote. Republican and Tea Party legislators in over a dozen states have imposed restrictions on voting by requiring photo identification and other IDs many people either don't have or are dissuaded from obtaining due to inconvenience or cost, even though they have legally voted in the past for decades, particularly the elderly. Other schemes to discourage early voting will have drastic impact on voter participation since many cannot take time off from work. Hawaii can be a shining example of democracy and enlightenment by passing HB1755 and fosters greater, not less, voter involvement.
