Re: HB 1926 HD1 Relating to Assaults Against Medical Services Providers

Chair, Vice Chair, and committee members thank you for this opportunity to provide testimony on this bill relating to violence against medical personnel.

Kaiser Permanente Hawaii supports this bill, but would like to offer amendments.

Violence against healthcare personnel appears to be on the rise. According to a U.S. Department of Labor, Bureau of Statistics, healthcare workers experience violent assaults at a rate four times higher than the national average. This type of violence, ranging from verbal to violent physical attacks, is becoming all too common, which negatively impacts medical personnel by reinforcing a common misconception that this type of violence is just part of the job.

Kaiser Permanente supports this bill to protect medical providers from unnecessary violence in the workplace, but asks that the scope of protection be expanded to also include <u>unlicensed</u> professionals, i.e. health care assistants, medical interns/externs, who are often on the front lines providing necessary medical care and therefore, vulnerable to the same workplace violence. Therefore, we ask that the definition of "medical services provider" in paragraph (1)(f), Page 3, line 2, be amended to also include "or other licensed <u>or unlicensed</u> medical professional involved in the direct care of patients."

Additionally, it is well recognized that as the baby boomer generation ages, the demand for home care services is expected to increase by 50 percent between 2002 and 2012 according to the Bureau of Labor Statistics. Therefore, given the increasing demand for home health <u>residential</u> services, we ask that the definition of "medical services provider" in paragraph (1)(f), Page 3, line 2, be amended to also include "<u>home health residential</u>" as a type of facility afforded protection under this bill.

Supporting HB 1926 HD 1 with amendments

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including all acute care hospitals, as well as long term care facilities, home care agencies, and hospices. In addition to providing quality care to all of Hawaii's residents, our members contribute significantly to Hawaii's economy by employing over 40,000 people. Thank you for this opportunity to testify in support of HB 1926 HD 1, which extends the enhanced penalties for violence against certain emergency medical services staff to others.

Health care workers have faced a significant risk of job-related violence for many years. Injury rates reveal the increased risk. The Bureau of Labor Statistics measures the number of assaults resulting in injury per 10,000 full-time workers in different categories. The overall private sector incidence rate is 2. The rate for health service workers overall is 9.3. The rate for nursing and personal care workers is 25.

Hawaii statute recognizes that certain groups deserve increased legal protection, such as educational workers, correctional workers, firefighters, and workers at State mental health facilities. Conduct classified as Assault in the Third Degree for others is classified as Assault in the Second Degree for these groups. Emergency medical service personnel in hospitals are also currently given increased protection. This bill is intended to extend the added protection to medical services staff in hospitals, medical clinics, and federally qualified health centers.

However, the text of the bill is unclear. The committee report submitted by the Committee on Health on the HD 1 version of HB 1926 describes the amendment as applying to medical services staff of long-term care facilities and specialized nursing facilities. However, the text of the bill may be interpreted to limit its application to those who work in emergency rooms of various types of facilities (page 2, line 20 to page 3, line 2). The bill should be amended to clarify that the increased protection applies to all medical services staff of hospitals, medical clinics, federally-qualified health centers, long-term care facilities, and specialized nursing facilities.

In addition, the Healthcare Association of Hawaii supports a further amendment so that the increased protection applies to medical services staff of home health agencies, home care agencies, hospices, physician offices, and dentist offices.

With these amendments, the Healthcare Association of Hawaii supports HB 1926 HD 1.

RE: Testimony in SUPPORT OF HB 1926 HD1, Relating to Assault Against Medical Services Providers

Chair Green, Vice- Chair Nishihara and members of the Committee. On behalf of the Hawai'i Chapter, American Organization of Nurse Executives ("AONE"), thank you for the opportunity to submit testimony in **support** of HB 1926 HD1, relating to assaults against medical services providers.

This measure would extend the offense of assault in the second degree to include harm upon medical professionals. The bill expands protections to professionals from several medical fields engaged in the performance of duty within various medical facilities, rather than limiting enhanced protection to emergency medical services providers only. We believe the measure is an important step toward enhancing protections for professionals who deliver much needed care and services to the community.

On January 30, 2012, the New York Times reported that the <u>2011 Health and Safety Survey</u> conducted by the American Nurses Association found 34 up from 25 percent in 2001; of registered nurses ("R.N.") rank "on-the-job assault" as one of their three greatest safety concerns. More than half of all R.N.'s report they were verbally threatened at work.

The <u>National Institute for Occupational Safety and Health</u> ("NIOSH") reports that from 2003 to 2009, eight R.N. nurses were killed at private healthcare facilities by gunshot wounds or fatal injuries. In 2009, 2,050 incidents involving harassment or violent assault were reported by clinical nurses who took an average of 4 days away from work to recover.

During the recent holiday season, a patient attacked a nurse at Queen's Medical Center. These attacks have ramifications for our community. A recent study of nurses nationwide sponsored by the National Institute of Health, revealed that one in three nurses over 45 plans to quit their jobs when the recession ends because of attacks in the medical workplace. Others believe they must just expect violence as part of their job.

Medical providers abide by the Hippocratic Oath to help those in need of medical attention, thus they deserve a high level of legal protection for their service.
