**Supporting HB 1952 HD 1: Relating to Bone Marrow Transplants.**

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including all acute care hospitals, as well as long term care facilities, home care agencies, and hospices. In addition to providing quality care to all of Hawaii's residents, our members contribute significantly to Hawaii's economy by employing over 40,000 people. Thank you for this opportunity to testify in support of HB 1952 HD 1, which appropriates funds for Hawaii Pacific Health to establish a bone marrow transplant center.

A bone marrow transplant replaces bone marrow that is either not working properly or has been destroyed by chemotherapy or radiation. Hawaii's only bone marrow transplant center closed earlier this year when Hawaii Medical Centers ceased operations. Patients who require bone marrow transplants must now travel to the mainland for treatment. Hawaii Pacific Health has stepped up to establish a bone marrow transplant center so that Hawaii's pediatric patients do not have to endure the travel and incur the expense of going to the mainland for treatment.

For the foregoing reasons, the Healthcare Association supports HB 1952 HD 1.

**Re: HB 1952, HD1 RELATING TO BONE MARROW TRANSPLANTS**  
**Testimony In Support**

Good morning. My name is Dr Randal Wada. I am a pediatric hematologist–oncologist practicing at Hawai'i Pacific Health (HPH) and have treated many young bone marrow transplant patients at Kapi'olani Medical Center for Women & Children over the years.

HPH is committed to continuing comprehensive bone marrow transplant services to our very vulnerable pediatric patient population, for whom travel to the Mainland for care is less feasible than for adults. We are concerned about the loss of the adult bone marrow transplant program at HMC and the negative effect this will have on adult cancer patients. However, the hospital's closure has also jeopardized our ability to perform transplants on children because of the concomitant loss or endangerment of vital support services that were previously housed there.

Key among them are the apheresis program, which provides the means to collect blood stem cells for subsequent transplantation, as well as the laboratory services needed to properly prepare these cells.

We estimate it will require about \$500,000 to support start up costs for a replacement stem cell collection program, which includes equipment, staffing and training. These resources could also be used to provide therapy for non-transplant patients with a range of neurological, hematological and auto-immune conditions. Once the pediatric bone marrow transplant program is firmly established, we will study the feasibility of support for adult transplants.

While it could ultimately become more self-sustaining, the initial costs of such a program would be difficult for us to bear, especially since we are in the midst of a major ongoing capital campaign to modernize and expand our hospital. For this reason, it is also unlikely that we would be able to secure additional matching funds to develop this new service, and, respectfully, request that this requirement be deleted from the bill.
