On behalf of the Hawaii State Commission on the Status of Women, I would like to thank the committee for this opportunity to provide testimony on such an important issue. I would like to express my strong support for HB 2227, which would amend HRS 338-17.7 by allowing for the establishment of new birth certificates for transgender individuals.

A statutory requirement for an actual surgical gender change is outdated and unnecessary. The majority of transgender people do not choose to undergo sex reassignment surgeries for various reasons, including prohibitive costs and other medical and personal reasons. Under internationally accepted clinical standards, transgender individuals may opt for hormone therapy and other treatments. The international medical community recognizes that surgery may be appropriate for some, but not for all. HB 2227 attempts to modernize HRS 338-17.7 and recognize the need for transgender individuals to live their lives in their new gender, without retaining an outdated notion of what it means to be transgender. This bill makes it less arduous for transgender individuals to request a new birth certificate by allowing an individual to request one from the Department of Health rather than petitioning a court to order the change.

The Commission respectfully asks that this Committee pass HB 2227.

Dear Chair Yamane and Members of the Committee on Health:

The ACLU of Hawaii strongly supports H.B. 2227 and thanks this committee for the opportunity to present testimony today regarding proposed amendments that eliminate barriers to the issuance of new birth certificates for transgender persons.

Current law presents numerous barriers to transgender individuals seeking to correct gender markers on birth certificates, including requiring that transgender individuals undergo costly and potentially dangerous surgical procedures without regard for whether a person wants or has any medical need for the surgeries.

A birth certificate is a vital document needed to obtain identification such as a driver's license or passport, to prove eligibility for employment, and to apply for many types of social services. Transgender persons face serious obstacles in accessing these necessary identity documents without a birth certificate that accurately reflects their current gender. Incorrect gender identification may lead to bias, harassment, or discrimination, and makes it more difficult for government officials or agencies to accurately identify transgender people.

For transgender individuals, identification documents can frequently function as a kind of scarlet letter, with the "F" or "M" designation contradicting the individual's appearance and expressed gender identity and outing him or her as a transgender individual. Transgender individuals may have trouble even cashing a check at the bank if the gender displayed on their driver's license does not reflect their appearance. Law enforcement is impeded too when individuals' identification documents fail to reflect their appearance and lived gender.

National survey data from the World Professional Association for Transgender Health indicate that transgender people who are unable to obtain gender-congruent identity documents are less likely to be employed and more likely to face discrimination in employment and housing. Transgender people commonly report experiencing harassment (40%) and being asked to leave a place of business (15%) as a result of showing identification that does not match their lived

gender, and significant numbers have also experienced physical violence as a result. Transgender people of color experience these adverse outcomes at substantially higher rates.

Accordingly, the American Medical Association advises that "transgender persons should have access to identity documents consistent with their gender identity and expression," and recommends that "those permanently socially transitioned to another gender role" not be made to "involuntarily disclose their status as transgender." The American Association of Motor Vehicle Administrators has also endorsed policies that would permit transgender drivers to obtain gender-congruent driver's licenses without proof of surgery.

H.B. 2227 conforms Hawaii's laws to those set by the United States Department of State for federal birth certificates given to U.S. citizens born outside of the U.S. (known as Consular Reports of Birth Abroad) as well as for gender marker changes on U.S. passports. In addition, a growing number of states have stopped requiring surgery for changing the gender marker on a driver's license.

Policies that follow these best practices are easy to understand and administer, ensure consistency in application, and most importantly, eliminate needless and harmful barriers for transgender people. Identification that reflects an individual's lived gender will also make it easier for law enforcement, customs, and other officials to quickly and accurately identify individuals in the course of their daily business.

Hawaii counties will soon consider similar changes to county ordinances that regulate the process to amend the gender marker on driver's licenses. We anticipate that those amendments will be heard in public hearing soon. Amending these laws and ordinances through the legislative and administrative hearing processes will avoid litigation like that recent brought in Alaska and Illinois by ACLU affiliates.¹

With the increasing demand for identification since September 11, 2001, it is particularly important that transgender persons have access to accurate identity documents. Without accurate

identification, transgender persons have limited ability to work, vote, travel, enter buildings, or otherwise participate fully in society. Transgender people need birth certificates that accurately indicate their true gender and reflect the individualized nature of transgender health care and experience.

Testimony in Support of HB 2272, Relating to Birth Certificates Re:

Planned Parenthood of Hawaii (PPHI) supports HB 2227, which streamlines the process for individuals to change their birth certificates to reflect their true gender and removes burdensome medical requirements.

We have a core set of beliefs at PPHI, and among them is the belief that the free and joyous expression of one's own sexuality is central to being fully human. The ability to express one's gender without fear is crucial to every person's well being. In 2011, in recognition of the need for quality and reliable health care for transgendered individuals, PPHI will begin providing transgender health care services at our Honolulu Health Center. It is our goal to expand these services to all of our health centers in the near future. We provide safe and compassionate preventive healthcare and screenings as well as hormone therapy.

Currently, the requirements for changing the gender on one's birth certificate include medical sex reassignment procedure. This requirement is outdated and unnecessary. Transgendered individuals opt out of sex reassignment surgery for many reasons. For many, the cost of surgery is prohibitive. Others choose not to have surgery for more personal reasons. Especially in Hawaii, transgendered individuals have great difficulty in finding affordable and safe medical care. The current requirements are a significant barrier for transgendered people to obtain birth certificates and other identifying documents that accurately reflect who they are. Therefore, PPHI encourages this committee to pass HB 2227. Thank you.

RELIGIOUS FREEDOM DENIED UNDER SMOKE AND MIRROR LAW


Remember the "pregnant man" that Oprah kept having on her show from a few years ago? Of course, the "man" at issue isn't a man at all, but Oregon law states that if you have a surgery, you can change your birth certificate (a VITAL RECORD). This woman had her breasts, and only her breasts, removed. She then proceeded to get her birth certificate changed. Then, although Oregon has a constitutional amendment protecting marriage as one man and one woman, she got a marriage license issued to her and her girlfriend. All because Oregon now considered her to be a "man."

In this true-life scenario above, a church could then provide marriage rites (unknowingly) to a samesex couple under the guise of false heterosexuality. Political activists know that blurring the sexes will ultimately make marriage meaningless. Honorable Chairs and members of the joint Senate Committees on Human Services and Health, I am Walter Yoshimitsu, representing the Hawaii Catholic Conference. The Hawaii Catholic Conference is the public policy voice for the Roman Catholic Church in the State of Hawaii, which under the leadership of Bishop Larry Silva, represents Roman Catholics in Hawaii.

We oppose this bill because our church teaches that the altered condition of a member of the faithful under civil law does not change one's canonical condition, which is male or female as determined at the moment of birth.


Marriage between members of the same sex is not legal in the State of Hawaii. Passage of this legislation opens the door to marriage between members of the same sex. Almost 70% of the people of Hawaii made it clear that marriage is between one man and one woman.

For matters like marriage, the church considers only the genetic gender of the individual. Thus a male who undergoes surgery to become female could not marry a man, even if they were able to obtain a marriage license, because the church would regard this as a same-sex marriage of two males. Further, a female who undergoes surgery to become a male will not be able to marry a woman even though the state would now consider them as an opposite-sex couple.

Language in the bill states "The new certificate shall not be marked as having been amended and shall in no way reveal the original language changed by the amendment. Thereafter, the original certificate and the evidence supporting the preparation of the new certificate shall be sealed and filed." Under this strict language, the Catholic Church, and other religious organizations, would have no way of knowing that the individual asking for marriage has assumed a different gender. That would indirectly put everyone in the position of officiating inadvertantly over same-sex "marriages."

During late 2008, Pope Benedict XVI said in a speech that our gender was a gift from the creator. He denounced those who would try to change it. He said: "It is a question here of faith in the Creator and of listening to the language of creation, the devaluation of which leads to the selfdestruction of man and therefore to the destruction of the same work of God."

Please do not pass this disingenuous legislation. Mahalo for the opportunity to testify.

Testimony in support of HB 2227 relating to birth certificates

Pride At Work Hawai'i, an affiliate of the Hawai'i State AFL-CIO which works to mobilize lesbian, gay, bisexual, and transgender (LGBT) workers and their supporters for full equality and to build mutual support between the labor movement and the LGBT community, supports HB 2227, which would expand the reasons to change gender on state birth certificates.

Current state law requires that a doctor certify that someone has undergone sex reassignment surgery in order to change gender on a birth certificate. However, surgery can be prohibitively expensive (and, like other transgender-related treatments, is not covered by Hawai'i health insurance plans), and many people who live as a different gender than their birth certificates show do not want or shouldn't have surgery. However, having an important government document like a birth certificate showing a different gender than how a person lives can create many problems, especially as governments and employers require identification for many purposes. Without the consistent identification (whether on drivers licenses, birth certificates, or passports) that many non-transgender people take for granted, it can be embarrassing - if not impossible - to travel, open a bank account, or apply for a job. It can also create many difficulties when dealing with government agencies and law enforcement.

This bill, by adding "hormonal or other treatment appropriate for that individual for the purpose of gender transition" to surgery as the allowable requirements to get a new birth certificate with a new gender designation, is an important step toward full inclusiveness for transgender and gender-non-conforming people, as is language requiring the State to seal the original birth certificate and not allow the new document to show that it is a replacement.

We strongly urge you to stand up for equality and fair treatment for all those born in Hawai'i by supporting this bill.

Aloha, Chairman Yamane, Vice Chair Morikawa and members of the Health Committee:

My name is Heath Hathaway Wyld, and I testify in strong support of HB2227, relating to birth certificates. I would like to thank you with the most heartfelt appreciation for your consideration of this bill, HB2227. I have some very personal testimony that I would plead that you consider. The fact is that it is truly essential, on an emotional and on an official legal level, for TS/TV individuals to achieve official legal confirmation of their perceived gender status. Among other things, this legal recognition serves to correct their sense of gender dysphoria. I am a male, and I identify as male; however my long-term partner is a TS/TV individual. I know a great many TS/TV individuals, I have personal knowledge related to this issue, and I most humbly plead that it be heard. I will not be able to attend in person, and so I beg you to accept and present my written testimony.

The fact of the matter is that MTF gender reassignment surgery frequently results in severe scarring, and it always results in an unnatural anatological configuration. Furthermore, many postop transsexuals are unable to acheive orgasm, whether or not they were able to achieve orgasm previously, after several years of taking hormones. As a result, there have been cases of transsexuals so dissapointed with the results of their surgery, that they have actually committed suicide as a result. Moreover, the surgery itself is inherently dangerous, in that serious complications can and do occur either during surgery or post-operatively, including fistulas, etc, and fatalities have been known to result. Moreover, one can never assume that the surgery would take place in the USA, since many gender dysphoric individuals from all countries go to Thailand for the surgery. The policy problem is that a man, in his zeal to have the opportunity to officially marry his beloved, might encourage her to undergo surgery she feels is unsafe. Or alternatively, his t-girl partner, in her zeal to legally and officially marry the one she loves, or in her zeal simply to be publicly recognized according to the gender she considers herself to be, might be encouraged to undergo surgery she would otherwise avoid as unsafe. A policy which requires the actual completion of gender reassignment surgery prior to the issuance of a new birth certificate is a policy which needlessly endangers lives. No one should have to put her life on the line simply in order to bring her legal gender identity in line with her perceived identity. It's just dead wrong.

I know for a fact that my TS/TV partner in Laos would like nothing more in life than for her official gender to match her perceived gender, but I also know that she fears that having MTF gender reassignment surgery would place her life in severe and unnecessary danger. Under no circumstances would I want her to undergo the risk. My partner and I know various transsexual individuals who have completed the surgery safely, but my partner and her friends also know of many individuals who were not so lucky. Frankly speaking, just typing this brings me to the point of tears, and I am a very masculine individual.

I most humbly and respectfully request that this committee pass HB2227.

Testimony of Lisa Mottet, Esq., Regarding HB 2227, Relating to Birth Certificates

Hearing in the Health Committee 9:00am --- February 3, 2012

Aloha, Chairman Yamane, Vice Chair Morikawa and members of the Health Committee:

Thank you for receiving this testimony in support of HB 2227, Relating to Birth Certificates. For the last ten years, I have served as the Transgender Civil Rights Project Director at the National Gay and Lesbian Task Force. In this role, I am proud to say that I have been involved with Hawai'i's transgender community's efforts to successfully pass hate crimes and non-discrimination legislation, all of which passed with overwhelming majorities through the Legislature over the past several years.

For transgender people, recognition of their gender is a matter of basic human dignity. In order to live as their authentic selves in a safe and stable way, transgender people need identification that represents who they are. Unfortunately, the National Transgender Discrimination Survey indicated that only 24% of transgender people nationally had been able to update the gender marker on their birth certificate. And, for individuals who showed ID in their daily life that did not match their gender presentation, 40% reported being harassed, 3% reported being assaulted, and 15% reported being denied entry or asked to leave. Although the number of participants in the survey from Hawaii was small (about 20 people), the information from those living in Hawai'i is similar to the national data:

- Only 22% of transgender Hawaiians said they had been able to update the gender marker on their birth certificate
- 28% of Hawaiians reported being denied this update to their birth certificate
- 50% of Hawaiians reported not even trying to update their birth certificate

Hawai`i has long had a law that allows people to obtain a new birth certificate reflecting who they truly are. Unfortunately this law contains procedural barriers that make the process onerous and confusing, and it has become out-of-date with current medical standards relating to transgender people. HB 2227, Relating to Birth Certificates, is a technical bill that would alleviate the confusion around what needs to be shown to update one's birth certificate, while also updating the medical requirements as well. In so doing, the bill should also reduce the anxiety - and real danger - that transgender people face when they have identity documents that do not reflect who they are.

HB 2227 would streamline current law regarding how people born in Hawai'i can receive an updated birth certificate. HB 2227 would allow people to use a simplified process that requires medical certification from a physician that the individual has undergone appropriate treatment for them to obtain a new birth certificate to reflect their gender. This change conforms Hawai'i's

standards to the standards set by the United States Department of State for federal birth certificates given to U.S. citizens born outside of the U.S. (known as Consular Reports of Birth Abroad) as well as gender marker changes on U.S. passports. Further, the bill contains information on how to indicate a name change has taken place, making the process more clear for qualified petitioners to navigate. HB 2227 also ensures that medical privacy is respected. Because it simplifies an already existing process, HB 2227 should be a cost-neutral update to this section of the law and may actually generate cost savings for the government in the long term.

Transgender people, like everyone else, deserve to live with dignity and respect. For transgender people, something as simple as government recognition of their authentic gender identity goes a long way. Thank you for considering this very technical, but important, piece of legislation.

For all of these reasons, I respectfully request that this committee pass HB 2227.

Chairman Yamane, Vice Chair Morikawa and members of the Health Committee,

My name is Darcianne Ernce and I support of HB2227, relating to birth certificates.

While studying for a Bachelor of Science Degree in Criminal Justice over 20 years ago, I learned that transsexuals are born identifying (believing, feeling, thinking, behaving) with the gender that is opposite of the physical gender they are born with. They will only feel whole and complete when they are able to become the gender they identify with since birth. If they grow up in an environment that is unaccepting of their gender identity, the psychological and emotional trauma that transsexuals face is significant. More than 50% of transsexuals will have attempted suicide at least once in their lifetime.
