My name is Lynn Bhanot, Executive Officer for the Board of Veterinary Examiners ("Board"). The Board is in support of House Bill No. 2242, H.D. 1, Relating to Continuing Education for Veterinarians.

The purpose of this measure is to mandate twenty credit hours of continuing education to renew a license.

The companion bill, Senate Bill No. 2522, was heard by your Committee and passed out as an S.D. 1. Both bills are very similar, except for technical, non-substantive differences. The Board prefers the language and format of Senate Bill No. 2522, S.D. 1.
