TESTIMONY ON HOUSE BILL NO. 2272 H.D.2 RELATING TO PROFESSIONS AND VOCATIONS

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND TO THE HONORABLE BRIAN T. TANIGUCHI, VICE CHAIR, AND MEMBERS OF THE COMMITTEE:

The Regulated Industries Complaints Office ("RICO") of the Department of Commerce and Consumer Affairs appreciates the opportunity to testify on House Bill No. 2272 H.D.2, Relating To Professions and Vocations. My name is Daria Loy-Goto, RICO's Acting Complaints and Enforcement Officer. RICO offers the following comments on the bill.

House Bill No. 2272 H.D.2 replaces the current definitions of "surveyor" or "land surveyor" with new definitions for "land surveying" and "professional surveyor", "professional land surveyor" or "land surveyor" in Chapter 464, Hawaii

KEALI'I S. LOPEZ DIRECTOR Revised Statutes, which governs professional engineers, architects, surveyors, and landscape architects. The bill also amends the current definition of "landscape architect" and is effective upon approval.

RICO notes that this Committee heard the Senate companion measure,

Senate Bill No. 2167, and passed the bill with amendments. The House

Committee on Economic Revitalization and Business (ERB) subsequently passed the bill with an H.D.1 that revised the defective date of the bill to July 1, 2112.

House Bill No. 2272 H.D.2 is substantially similar, but not identical, to Senate Bill No. 2167 S.D.1 H.D.1 and does not have a defective effective date. In comparing the House and Senate versions, RICO prefers the language in Senate Bill No. 2167 S.D.1 H.D.1, except for the defective effective date. In particular, RICO prefers the phrase "but is not limited to:" on page 1, lines 15-16 of Senate Bill No. 2167 S.D.1 H.D.1.

Both House Bill No. 2272 H.D.2 and Senate Bill No. 2167 S.D.1 H.D.1 represent the combined efforts of the Board of Engineers, Architects, Surveyors, and Landscape Architects, industry groups, and RICO to update existing definitions that would capture the full range of conduct performed by land surveyors.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Dan Hirota, surveyor member of the Board of Professional Engineers, Architects, Surveyors and Landscape Architects ("Board"). The Board appreciates the opportunity to testify in support of House Bill No. 2272, H.D.2, Relating to Professions and Vocations.

The purpose of House Bill No. 2272, H.D.2, is to replace the existing definition of "surveyor" or 'land surveyor" with definitions for "land surveying" and "professional surveyor, 'professional land surveyor, or 'land surveyor' and to clarify the definition of "landscape architect".

The Board believes the existing definition for "surveyor" or "land surveyor" is outdated and does not reflect the full scope of practice of land surveying. Amending the definition of land surveying would provide a more accurate description of the activities involved in the practice of land surveying.

The companion bill, Senate Bill No. 2167, was heard by your Committee and passed out as S.D.1. Both bills are very similar, except for technical, non-substantive

differences. The Board prefers Senate Bill No. 2167, S.D.1, if the effective date in Section 3 is amended to be upon approval of the Act.
