TO CHAIRPERSONS YAMANE AND RHOADS AND MEMBERS OF THE COMMITTEES:

The purpose of H.B. No. 2374 is to transfer the Office of Language Access to the Department of Health, as an administratively attached agency, effective July 1, 2012.

The Department of Human Resources Development has **comments** on the proposed transfer. To protect the rights and benefits of the employees to be transferred, we prefer the following proposed transfer language be used in place of the transfer language pertaining to employees in Section 5 of the bill:

"All employees who occupy civil service positions and whose functions are transferred to the department of

health by this Act shall retain their civil service status (permanent or temporary). Employees shall be transferred without loss of salary, seniority, retention points, prior service credit, any vacation and sick leave credits previously earned, and other rights, benefits, and privileges, in accordance with state personnel laws and this Act, provided that the employees possess the qualifications public employment minimum and requirements for the class and/or position to which transferred or appointed, as applicable, provided further that subsequent changes in status may be made pursuant to applicable civil service and compensation laws.

Any employee who, prior to this Act, is exempt from civil service and is transferred as a consequence of this Act, may continue to retain the employee's exempt status, but shall not be appointed to a civil service position because of this Act. An exempt employee who is transferred by this Act shall not suffer any loss of prior service credit, any vacation and sick leave credits previously earned, or other employee benefits or privileges as a consequence of this Act, provided that the employees possess legal and public employment requirements for the position to which transferred or appointed, as applicable; provided that subsequent changes in status may be made pursuant to applicable employment and compensation laws. The director of the department of health may prescribe the duties and qualifications of such employees and fix their salaries without regard to chapter 76, Hawaii Revised Statutes."

Thank you for the opportunity to submit testimony in support of H.B. No. 2374, Relating to Language Access.

The Office of Language Access (OLA) strongly supports this bill, which would transfer the office from the Department of Labor and Industrial Relations (DLIR) to the Department of Health (DOH) as an administratively attached agency.

The OLA was established by law in 2007 to address the language access needs of limited English proficient persons and ensure meaningful access to services, programs, and activities offered by state and state-funded agencies for limited English proficient persons. The office provides oversight, central coordination, and technical assistance to state agencies in their implementation of language access requirements under the law.

The DOH has, as one of its purposes, the provision of health equity to all groups in Hawaii. The provision of language access helps to eliminate health disparities among our multi-ethnic population thereby promoting the total well-being of all. The functions and activities of the OLA are, therefore, congruent with those of the DOH.

The bill is a step forward in the implementation of the third focus of the present administration's New Day Plan: "to transform State government into an efficient and effective enterprise," and is in line with the New Day objective "to protect the human and civil rights of all regardless of categories." By transferring the functions and duties of the OLA from the DLIR to the DOH, this bill will help align state functions and improve the State's delivery of vital language services to its more than 140,000 limited English proficient population, provide them better access to needed government services, protect their rights, and enable them to become more active participants and contributing members to society.

The transfer will enable OLA to more effectively and efficiently use its resources and perform its functions. Being located in an agency that performs similar purposes and serves a similar population will result in better collaboration and sharing of resources, thereby making OLA more responsive to the community and the state and state-funded agencies it serves. Better language access means better customer service thereby helping raise public awareness and confidence in government and our processes.

For these reasons, the OLA urges the members of the two committees to approve this legislation.

The Hawai'i Civil Rights Commission (HCRC) has enforcement jurisdiction over state laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state-funded services. The HCRC carries out the Hawai'i constitutional mandate that "no person shall be discriminated against in the exercise of their civil rights because of race, religion, sex or ancestry". Art. I, Sec. 5.

H.B. No. 2374 transfers the functions and duties of the Office of Language

Access (OLA) from the Department of Labor and Industrial Relations to the Department
of Health. The HCRC is an ex-officio member of OLA's Language Access Advisory

Committee, and has historically supported the formation of OLA to address the language
access needs of limited English proficient persons to state and state-funded services,

programs, and activities. The HCRC supports the administration's and OLA's decision to move the program to the department that it feels most suited to perform its functions.

Thank you for the opportunity to submit testimony on H.B. No. 2374, Relating to Language Access. The Filipino Coalition for Solidarity supports this bill, which would transfer the Office of Language Access (OLA) from the Department of Labor and Industrial Relations (DLIR) to the Department of Health (DOH) as an administratively attached agency.

The Filipino Coalition for Solidarity was formed 22 years ago for the primary purpose of advancing civil rights and social justice for Filipinos and other minority groups through education, advocacy and social action. Language barriers are among the most serious challenges that Filipinos face in Hawaii, and our interest in language access issues is therefore very strong.

More than 140,000 of the state' total population of 1.3 million more than ten percent of the total have only limited proficiency in English. Language barriers impair the ability of this large segment of the population in all aspects of living, most importantly health.

OLA was established by statute in 2007 to address the language access needs of the ten percent of our people who have limited proficiency in English, and to help ensure that they have meaningful access to services, programs, and activities offered by state and state-funded agencies that will help them gain proficiency in English. OLA provides oversight, central coordination, and technical assistance to other state agencies as they implement the language access requirements of state and federal laws.

The Department of Health has, as one of its purposes, the goal of ensuring that access to health care not be impeded by language barriers. We know that, as in many other fields, language access helps to eliminate health disparities in Hawaii' multi-ethnic population, and improvement of health care in one community promotes the overall well-being of our entire society.

This bill helps implement one of the key goals of Governor Abercromble' New Day Plan: "to transform State government into an efficient and effective enterprise," by promoting the New Day objective "to protect the human and civil rights of all regardless of categories." Governor Abercrombie' administration has determined that transferring OLA to DOH will help improve the State' delivery of vital language services to this very large sector of our people, by giving them better access to needed government services, protecting their rights, and enabling them to become more active participants and contributing members to society.

For these reasons, the Filipino Coalition for Solidarity joins the administration and others in urging your two committees, and the entire Legislature, to approve this bill.
