Regarding HB 243 (formally Senate Bill 700); we commend the movement to address feline overpopulation with NON-lethal methods and support legislation to this end.

Our society has shown us that it is incapable/unable of responsibly managing pet overpopulation problems "on its own", AND that lethal or inhumane methods are not acceptable.

Measures such as mandatory sterilization, Trap-Neuter-Release (TNR) programs, commercial animal breeding restraints, and consideration for future Bills that mandate a surcharge on all state pet sales to fund such programs appear to be our only solution.
