Chair Takumi, Vice-Chair Au Bellatti and members of the House Education Committee, thank you for this opportunity to provide testimony in support of House Bill (HB) 2519, Relating to Education (Ed).

HB 2519 supports one of Governor Abercrombie's more important priorities, early childhood education. Research has found that over 85 percent of a child's brain development, in response to the stimulation the child receives, happens by age five. With our youngest children, it is about establishing healthy attitudes towards learning and positive social behavior so children can be ready to succeed in kindergarten and in life.

In 2011, the Department of Education reported that state-wide about 42 per cent of Hawaii's public school kindergarten students did not attend preschool. Many of Hawaii's DOE elementary school principals and child advocates say kindergarteners without preschool experience are more likely to enter school far behind their peers.

Research has also shown that investing in high quality early childhood education programs produces significant returns later. In Hawaii, every \$1 spent in high quality early childhood education realizes a \$4.20 reduction in costs for future educational and social interventions.

The Administration's supplemental budget contains a request for \$500,000 for the early learning council and the governor's early childhood coordinator to further develop and implement our State's framework for a comprehensive early childhood system with the goal that all of Hawaii's children, prenatal to age five, will be valued, safe, healthy and ready to succeed in school. The pillars of this

framework are, early education and care; health; parent education and family support; and workforce and professional development. This funding will also develop, execute, and monitor a phased implementation plan for a public-private preschool program for four-year olds, with identified potential sources of sustainable revenue.

We want to inform the committee that the Senate Education Committee hearing passed SB 2545 which will serve as the Senate vehicle for the Administration's early childhood education initiative. The Governor's office has participated in the development of the Senate bill and will work with the House to ensure that the Governor's initiative is passed by end of this Legislative session.

The Early Learning Council ("ELC") offers this testimony in support of HB 2519, related to early learning.

Established under Act 14, First Special Session 2008, the Early Learning Council is entrusted with the development and administration of the state's early learning system. The ELC seeks to establish a cohesive, comprehensive, and sustainable early learning system that ensures a spectrum of quality early learning opportunities for young children from their prenatal period until the time they enter kindergarten. As such, the ELC focuses upon four essential areas: Early Education and Care; Health; Parent Education and Family Support; and Workforce and Professional Development.

Since its inception, the ELC has completed and received approval for a statewide early childhood system framework, has partnered and provided advice on the development of a State Quality Improvement and Rating System, has supported the drafting of professional competence requirements for early learning practitioners, and most recently completed a Fiscal Mapping study (funded by the Omidyar Foundation) to measure the resources currently available in the State for Early Childhood services (e.g. education, health, nutritional and social services, special education services and family and professional training and development. Finally, the ELC has launched the "Be My Voice" campaign, which is targeted to impact the next biennium.

Thus, it was not able to meet to discuss the specifics of this bill before testimony was needed. The Council, however, does support funding for early learning and supports advancing this bill. We look forward to continuing to work collaboratively and proactively with the legislature and the broader community. Thank you for the opportunity to testify.



Dear Chairs Takumi & Bellati and Members of the Committee,

The 17 Community Children's Councils (CCCs) of Hawaii **strongly supports** HB2519 which proposes to appropriates funds out of the general revenues to the Department of Education to develop a public-private preschool program for four-year olds to support early childhood education.

The CCCs are community-based bodies comprised of parents, professionals in both public and private agencies and other interested persons who are concerned with specialized services provided to Hawaii's students. Membership is diverse, voluntary and advisory in nature. The CCCs are in rural and urban communities organized around the Complexes in the Department of Education.

The CCCs have long held that all children, with and without disabilities, benefit from quality, early learning programs that address their unique needs and help prepare them for long-term academic success. Three projects in particular have excellent follow up data: one in Michigan, called Perry or *High/Scope* (Schweinhar & Weikart, 1997; Schweinhart et al., 2005); one in North Carolina, called *Abecedarian* (F.A. Campbell et. Al., 2001); and one in Chicago, called *Child-Parent Centers* (A.J. Reynolds, 2000); A.J. Reynolds et al., 2004). All the evaluations of these three programs reached the same conclusions, which is now accepted by developmentalist: Good early education has many long-term benefits. Children in these programs scored higher on math and reading achievements tests by age 10 from the same backgrounds, schools, and neighborhoods. They were also significantly less likely to be placed in special classes for slow or disruptive children or to repeat a year of school. (Berger, 2010)

The CCCs maintain that this is will be one option for the gap group of four-year-olds who will be displaced by the repeal of Junior Kindergarten. The CCCs promote *high quality* early education that leads to lasting cognitive and social benefits for all children.

The Good Beginnings Alliance is a policy and advocacy organization focused on Hawaii's youngest children and their families. We strive to ensure a nurturing, safe and healthy development for all children from pre-birth to age eight. The following information is provided to help you in your decision-making process:

- Hawai'i is currently one of only 10 states which does not support an early learning program for children prior to kindergarten entry.
- Many states have achieved great successes in developing a comprehensive quality early
 childhood system after they established an executive office on early learning. We
 believe creating this office in Hawaii will be critical to ensuring all of our keiki are safe,
 healthy, and ready to succeed.
- Other states have also established an early learning advisory board/council that advises
 the executive office of early learning. This early learning office provides the authority
 and accountability to convene the different stakeholders of an early childhood system and
 bring a state early childhood plan to fruition. The council provides the opportunity for
 community and stakeholder input into the work of the office.
- It is crucial to provide the new Early Childhood Coordinator with the necessary resources in order to achieve the outcomes expected of this office. The major outcome in the coming year is the office's a mandate to further develop and implement the components of our State's comprehensive early childhood system and monitor a phased implementation plan for four-year olds.
