Aloha Chairman Chang of the Water, Land and Ocean Resources Committee, Madam Chair Cabanilla of the Committee on Housing, and members of the joint committees. I am Soulee Stroud, president of the Association of Hawaiian Civic Clubs testifying in support of House Bill 2528 Relating to the Department of Hawaiian Home Lands. I represent sixty component clubs in all areas and counties of the State of Hawaii, as well as eleven states on the continent.

The first Hawaiian Civic Club was founded by Prince Kuhio as a means to help with the passage of the Hawaiian Homes Act in the U.S. Congress in 1920. There is a natural affiliation with the Department of Hawaiian Home Lands that has continued since that time and many civic club members are currently homesteaders or lease applicants.

This bill is another of several attempts by the current HHL administration to alleviate the extensive waiting list of applicants for residential leases. This would allow the development of a housing project to begin without the need to have the entire cost of the project on hand at the first turn of a shovel.
