RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS.

Chair Hanohano, Vice-Chair Lee, and committee members, thank you for the opportunity to testify on HB 2529. This bill allows an exemption from HRS chapter 103D, Hawaii Public Procurement Code (Code), for expenditures and procurements less than \$250,000 made from Hawaiian home trust funds.

The State Procurement Office (SPO) opposes this bill. The department should follow the source selection methods identified in Part III of HRS chapter 103D for contract awards regardless of dollar amounts.

Public procurement's primary objective is to provide everyone equal opportunity to compete for government contracts, to prevent favoritism, collusion or fraud in awarding of contracts. To the extent agencies may need specific purchases to be exempt from the procurement code requirements; the code provides an exemption process.

There is nothing unique or special in the awarding of these funds that cannot be accommodated in the Code.
