The Office of Hawaiian Affairs (OHA) offers the following comments on HB2531, which would allow the chairman of the Department of Hawaiian Homelands (DHHL), with unanimous consent of the commission, to suspend administrative rules and award a lease to a beneficiary who has been on the waitlist for at least twenty years.

Our primary observation is that the bill could greatly benefit from further details to support its main proposal. For example, the justification for the bill indicates that the proposed waiver would allow DHHL to provide beneficiaries with access to new products it is developing. However, the bill itself does not explain when and how the waiver can be used. The bill is also silent regarding other significant details. Therefore, we recommend that the following points be addressed in either the preamble or the body of the bill, or through rulemaking:

- How DHHL will justify choosing between multiple beneficiaries who have been applicants for more than twenty years.
- Why twenty years is the operative cut-off date.
- That the waiver is meant to facilitate the placement of families into new DHHL products such as multi-generational housing (if that is, in fact, the intent of the waiver).
