#### HB 2626 RELATING TO SAFE ROUTES TO SCHOOL

### HOUSE COMMITTEE ON TRANSPORTATION

The Department of Transportation (DOT) supports the intent of HB 2626 and offers the following recommendations:

- Subsection 291C-A(b) Use <u>federal safe routes to school</u> program in the <u>last</u> <u>sentence</u> to differentiate from a county safe routes to school program.
- Subsection 291C-A(c) Replace <u>The director of transportation, through the safe</u> routes to school program coordinator with <u>A county-designated office, through</u> the county safe routes to school program coordinator to streamline to use of SRTS Special Funds and remove conflicts with federal law requiring the equal opportunity use of federal funds.
- 3. Subsection 291C-A(d) Use <u>county safe routes to school program</u>.
- Subsection 291C-A(d)(1) Replace the <u>department of transportation</u> with <u>a</u> <u>county-designated office</u>.
- Subsection 291C-A(e) Use <u>county safe routes to school program</u> to remove conflicts with federal safe routes to school requirements.
- 6. Subsection 291C-A(g) Use <u>federal safe routes to school program</u>.

- 7. Subsection 291C-B(a)(1) Delete this subsection and renumber accordingly as this is not allowed under current federal regulations. The federal-aid program is a reimbursable funding program. The Federal Highway Administration (FHWA) will only approve reimbursement of federal SRTS funds when a pertinent SRTS project has been deemed to meet federal regulations, including environmental, bidding and construction regulations.
- Subsection 291C-B(b) Replace <u>traffic calming measures</u> with <u>purposes outlined</u> in 291C-A to not limit improvements to only traffic calming measures. Some counties have moratoriums on traffic calming measures such as the City and County of Honolulu.

The intent of the revisions is to make the use of the SRTS Special Fund by the counties to be as flexible as necessary to get improvements processed and done as smoothly as possible. This can only be accomplished if the counties are able to operate their respective program as independently as needed for the purposes of the national SRTS program.

#### RELATING TO SAFE ROUTES TO SCHOOL

House Bill No. 2626 establishes the Safe Routes to School Program within the Department of Transportation to enhance traffic safety around Hawaii's schools. A Program Coordinator position will be established within the Department of Transportation that, along with the Director, will be tasked with the overall coordination of the program including maximizing the participation of stakeholders, and training volunteer workshop facilitators and potential grant requestors. Proceeds from fine surcharges resulting from traffic violations related to the operation of motor vehicles and to speeding in school zones, and any federal funds received for the program, are to be deposited into a new Safe Routes to School Program special fund and distributed by the Director of Transportation to the counties. Not less than 10 percent and not more than 30 percent of the funds shall be used for non-infrastructure related activities. However, it should be noted that this bill does not contain any appropriation for the new special fund.

The Department of Budget and Finance takes no position on creation of the Safe Routes to School Program. However, as a matter of general financial policy, the department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 2626, it is difficult to determine whether the new fund will be self-sustaining or that there is a clear nexus between benefits sought and charges made upon the driving public.

- 14 SRTS Programs. Current programs have been extremely successful in increasing the numbers of

2	This bill would create a sustainable means for generating revenue for funding this important program
3	and will help to increase and build upon SRTS efforts throughout our state. Since, Hawaii school-aged
4	(5 to 18 years of age) residents have the highest rates of pedestrian injuries requiring hospital treatment
5	or death, it is another important reason to utilize funding to create a safe and integral transportation
6	system for a large and valuable demographic of Hawaii's population.
7	The Department of Health (DOH) respectfully defers to the DOT on recommended language
8	related to the funding structure of this bill. Should this bill be enacted we recommend that the DOT
9	consults with the DOH to implement the Safe Routes to School Program. The DOH supports the intent
10	of the measure as long as it does not have a negative impact on the Department's Supplemental Budget
11	appropriation request.

#### **TESTIMONY IN SUPPORT OF HB 2626**

Chair Souki and members of the Committee:

The Blue Planet Foundation supports HB 2626, a measure establishing the Safe Routes to School Program within the Department of Transportation funded through a surcharge for certain traffic violations. We believe passage of this measure will decrease reliance on automobiles for students commuting to and from schools.

Blue Planet Foundation's mission is to end the use of fossil fuels on Earth, starting by making Hawai'i a role model for energy independence. While much of our work has been focused on renewable energy and reducing electricity use, transportation in Hawaii (cars, trucks, ships, and planes) accounts for approximately two-thirds of the oil consumed. In 2011, Hawaii cars burned over 470 million gallons of gasoline. For a typical car, that's enough gasoline to cover the distance equivalent to over 21,000 round trips to the moon. Providing alternatives to driving cars is needed to decrease our consumption of gasoline and other fossil fuels. Better yet, showing children that walking and biking can be enjoyable can help establish healthy habits for life. This measure seeks to make the routes to schools safer so more students are able to choose walking and biking as a means of commuting.

In July 2005, Congress passed federal legislation that established a National Safe Routes to School (SRTS) program. The program, which was signed into law in August 2005, dedicates a total of \$612 million towards SRTS from 2005 to 2009. The Federal Highway Administration administers the Safe Routes to School program funds and provides guidance and regulations about SRTS programs. Federal SRTS funds are distributed to states based on student enrollment. Safe Routes to Schools funds can be used for both infrastructure projects and non-infrastructure activities. The legislation also requires each state to have a Safe Routes to School Coordinator, which HB 2626 provides within the DOT, to serve as a central point of contact for the state. Hawaii stands to gain its fair share of SRTS funding through passage of this measure.

Blue Planet supports HB 2626 as common sense legislation to help us make our roads safer, improve the health of our children, and decrease our reliance on fossil fuels.

I thank you for the opportunity to provide testimony on HB2626 Relating to Safe Routes to School, a bill that would permanently establish the Safe Routes to School Program within the Department of Transportation, establish a Safe Routes to School Special Fund and assess a surcharge of \$25 for violations of speeding in a school zone and a \$10 surcharge on various traffic violations and deposits these surcharges into the Safe Routes to School Special Fund.

In a time where the vehicle is the predominant mode of transportation on our island streets, where children are increasingly overweight and or obese, and so many of us spend time working instead of being able to enjoy the outdoors, NOW is the time to move forward with firmly establishing initiatives that can support modes of "active transportation". (i.e. running, biking, skateboarding, and any other form or human-powered transport necessitated by physical activity)

As a supporter of active transportation and having spent over 5 years working on physical activity and nutrition issues in the State, I know that the percentage of children who are overweight or obese increases year after year, that children with asthma are adversely effected by idling vehicles in front of schools and that in we spend more time in our cars rather than using transit, walking or biking. From traveling across the State's, conference after conference speakers re-iterate "that this generation may be the first in more than 200 years to live shorter life spans than their parents." Is that what we want? Would you want the children, the children of our great State to have a shorter life than the rest of us? What is it that can make the difference?

Transportation policies are integral in making significant changes to our environment, the way in which we commute to and from places and what the future holds for our children is embedded in the decisions you as legislators make.

SUBJECT: HB 2626 Safe Routes to School - Support with Changes

Aloha Chair and Committee Members,

Thank you for allowing me to provide testimony on HB 2626 which would create a permanent Safe Routes to School (SRTS) fund for Hawaii. The timing of this bill is very important, given the current state of federal funding for biking and walking. (The current version of the federal highway bill, the American Infrastructure and Energy Jobs Act, has stripped all funding for biking and walking programs. The senate bill, MAP-21, reduces funding for biking and walking programs.)

I support the creation of a SRTS fund and dedicated full-time coordinator, which is also required under federal funding, but would like to suggest consideration be given to the following changes.

The bill requires non-infrastructure funding be between 10% and 30%. Noninfrastructure funding should be increased to a minimum of 30%. Based on my experience and discussions with parents, teachers and community members, many people are still not even aware of SRTS. Education and encouragement, which fall under non-infrastructure, need additional support at this time.

The current structure of the program requires organizations and agencies to front the costs of each grant, i.e., grants are funded on a reimbursement basis only. The Hawaii Bicycling League was one of the first organizations to obtain a SRTS grant in Hawaii. It had to rescind it, however, because it could not front the costs. Consideration should therefore be given to revising this requirement so organizations do not need to wait so long for funding.

Lastly, I urge committee members to support the Hawaii SRTS Day Challenge. As schools register to participate in the challenge, legislators will be asked to join kids walking and biking to school on the fourth Wednesday of each month starting February 22. May 15 has been set aside as a special Bike and Walk to School day. More information is available at <u>www.pathhawaii.org/hui</u>.
