Aloha Chair Tsuji and members of the committee

My name is Anthony Aalto. I am a resident of Honolulu, a taxpayer and a voter, and I thank you for this opportunity to testify.

I strongly support this bill and I urge you to do the same.

The latest numbers from the US Department of Agriculture show that Hawai'i grows just 8% to 10% of all the food that we consume. Since statehood we have paved over more than 53% of our prime A & B food-producing agricultural lands, according to the College of Tropical Agriculture and Human Resources at the University of Hawaii.

It is urgent that we start to grow a lot more food and in order to do so we need to protect more of our best farmland.

The Abercrombie administration has committed to boosting the amount of food we grow, but has so far done nothing practical to advance such an agenda.

Given that the Land Use Commission has failed so spectacularly to fulfill its constitutional obligation to protect farmland and boost our state's self-sufficiency, this bill fills a vital need and would facilitate acquisition by the state of prime aglands.

I urge you to pass this measure.

In Opposition to HB 2666 Relating to Agricultural Land

Aloha. The Conservation Council for Hawai'i opposes HB 2666. The Legacy Land program is working well. In fact, it is one of the most successful programs for acquiring and protecting land for public purposes, with broad public support and participation. Please support all aspects of the program and do not place agricultural projects over watershed protection, habitat for rare and endangered species, projects that perpetuate the Native Hawaiian culture, recreation areas, open space, and public access.

CCH was one of hundreds of citizens and organizations that worked organized to pass the bill creating the Legacy Land Fund in 2005. This program is very popular among the people, and it provides opportunities for public involvement at its best. Since its inception in FY2006, the Legacy Land program has funded a diverse variety of positive environmental, cultural, historical, and agricultural land protection projects supported by state agencies, counties, and non-profit organizations.

HB 2666 unnecessarily and unfairly prioritizes certain agricultural projects over the other valuable public purposes of the Legacy Land program.

Under the current law, state and county agencies and non-profit land conservation organizations may apply. Applicants must submit applications and compete with other applicants for funding in a transparent and open process.

The best, most prepared/ready-to-go, and significant land projects should get funded. Competition ensures good land conservation.

Agricultural projects have been funded by the Legacy Land program, including one proposed by the Agribusiness Development Corporation.

There is no reason why agricultural projects that have infrastructure resources and easement funding approval from the state Agribusiness Development Corporation would not compete well for funds under the current law and application process.
