Thank you for the opportunity to submit testimony on H.B. 2742. The Office of Information Practices ("OIP") takes no position on this bill, which would exempt the county councils from the Sunshine Law.

The county councils are currently subject to the Sunshine Law. Like other state and county boards subject to the Sunshine Law, each county council is structured as a single body with a membership of no more than nine members (unlike the much larger and bicameral structure of the Legislature). Like the Legislature, which is exempt from the Sunshine Law, the county councils are legislative bodies that do their work primarily through bills and have their own rules governing their proceedings, which they currently follow in addition to the Sunshine Law. County or municipal level legislative bodies in other states are typically subject to those states' open meetings laws.

OIP believes the question of whether Hawaii's county councils should remain subject to the Sunshine Law, like similarly structured boards, or be exempted, like the Legislature, is a policy question for the Legislature to determine. For this reason OIP has not taken a position on the issue.

Dear Chair Keith-Agaran, Vice Chair Rhoads, and committee members,

The Environmental Center opposes House Bill 2742 and its intent to exempt the county councils from the Sunshine Law. The Sunshine Law and its applicability to county councils has been a cornerstone of our state's democratic process for the last 36 years, and the proposed measure does not explain why we should now change our interpretation of the policy and intent declared by the legislature in 1975, Act 166. If a certain aspect of the Sunshine Law is unreasonably troublesome or offensive to county councils in particular, then we suggest that the legislature consider a problem-specific remedy, rather than a wholesale exemption from the process. "Opening up the governmental processes to public scrutiny and participation is the only viable and reasonable method of protecting the public's interest." Hawaii Revised Statutes § 92-1.

Thank you for considering our testimony to oppose this proposed legislation. Please note that our testimony is advisory only and should not be construed to represent an official institutional position of the University of Hawaii.

Chair Keith-Agaran, Vice Chair Rhoads, and Committee Members:

Common Cause Hawaii strongly opposes HB 2742, which exempts county councils from the Sunshine Law.

Under this proposal, county councils would no longer be required to post meeting notices six days in advance to inform citizens. Council members would be able to meet secretly on official business and make major decisions behind closed doors, away from public view and without public input.

There are huge issues at stake at the county level – such as rail, land use and development, and waste, just to name a few. These issues have proven to inspire great attention and concern by citizens, with enormous impacts on our daily lives and our wallets. It is crucial that citizens have the ability to be part of these important conversations and decisions.

We understand that the six day notice requirement may be cumbersome at times, but it is still a small amount of time from the perspective of the public. Six days is a very short period of time for citizens to think about a new issue, discuss it, prepare comments or testimony, and make personal arrangements to attend a meeting (e.g., take time off from work, plan for childcare, and arrange transportation). Without transparency and ample lead time, regular citizens are shut out, and only those who are very experienced or well-connected are able to participate effectively and have their voices heard.

We urge the Committee to hold this bill. Mahalo for the opportunity to submit testimony.

The very first Article I of our State Constitution entitled "Bill of Rights, Political Power" sets forth the following, basic proposition:

Section 1. All political power of this State is inherent in the people and the responsibility for the exercise thereof rests with the people. All government is founded on this authority. [Am Const Con 1978 and election Nov 7, 1978]

HB 2742 would violate this fundamental proposition by proposing to exempt all county councils from the Sunshine Law.
