Written Testimony from Gail Ellingson, Individual Bill: HB 2749

In Absolute Opposition

I love dogs. Much of my life I've been lucky to have a dog companion. However, it is simply ludicrous to imagine people's pet dogs, (other than service dogs) in restaurants.

When I was 11 years old, I witnessed my sweet, well behaved, loving collie mix bite off the entire upper lip of my girlfriend ~ whom she knew for 5 years, because we were playing with her puppies and had made a movement too fast. As I stood frozen in fear screaming at the blood streaming from my friend's face, my Mom swooped in, grabbed her unattached mouth and rushed her to the hospital. I will always remember that moment frozen in time.

My friend had over a hundred stitches in her mouth and face, swelling, surgeries and scars and pain for a lifetime. I was filled with such shame ~ and the knowledge that our four legged friends are still animals ~ as we are ~ and sometimes unpredictable. Remember the story of the chimpanzee who ripped off the face of the owner's friend, now blinded and faceless, she lives on. Ask her what she thinks about this bill.

We hear horror stories of beloved family pets who turn on owners, children, babies and other animals in an instant. The general public should not be put at risk because someone has come up with the idea that it would be wonderful to bring our pets everywhere.

They do not belong in food establishments, stores and other places in public.

Feces, fleas, urine and the risk of someone or another dog getting bitten or attacked are a few more reasons to consider canning this bill forever.

Can you imagine the stench outside the entrance of such establishments, along the walkway, sidewalk or parking areas as the doggies diners are encouraged to pee one more time before eating? How will anyone prevent this? Already dogs are at liberty to pee anywhere they walk, and not everyone carries a doggie bag or conscience to always scoop the poop.

That a hired by me legislator even came up with a waste of bill such as this, shows the lack of intelligence in this governing body ~ including the Governor and his wife. It always made me nervous, but for the sake of the blind or wheelchaired person, it was compassion for the situation that justified the dog being there.

In the situation of HB2749, it is not a necessity to bring pets to eating places.

Already I have seen owners let their dogs sit on cushions and outside chairs of some places that don't monitor their outside tables. Those dogs may have just peed or pooped and now it's sitting on a place where the next unsuspecting guest (me/you?) might sit.

I have strolled through outdoor shopping malls and seen clumps of dog feces on the sidewalks, some stepped in, some ground in, some still soft and steaming. As much as you think this could be a controlled situation, there are still many irresponsible dog owners. Please do not subject us to any more places where we have to be diligent regarding dogs.

And really, not all dog owners treat their pets for fleas. Fleas can jump on and off anyone and hitch a ride home. I will not support any restaurant that would allow dogs.

And what about insurance? Who's going to pay for the hospital bill if someone's Fido gets furious? The restaurant? The dog owner?

Children often run up to stranger's dogs ~ who will be responsible if that child is bitten, mauled or killed?

In the end, if this bill should somehow slip through, it will be each and everyone of you who would put their stamp of approval.

Please, for the sake of everyone, kill House Bill 2749 before it kills anyone. You cannot know the behavior of every single dog and owner. It is your responsibility as a Law Maker to use common sense for the sake of all.

Dear Honorable Chair Keith-Agaran, Vice-Chair Rhoads and Members,

The Hawaiian Humane Society supports the passage of this bill and supports restaurant owners and managers in having the right to choose whether to allow dogs in their restaurants or not.

Current health code interpretations disallow all animals except service dogs in eating establishments. The Hawaii State Department of Health was asked in 2010 to reconsider their interpretation of the existing administrative rules that prohibit well-behaved dogs and their owners from dining together at private establishments.

Through our Dogs in Restaurants Advocacy Initiative, we have recruited the following restaurants who agree that they should be able to choose to allow dogs with their patrons or not: Brasserie du Vin, Baci Bistro, Big City Diner, Doraku Sushi, Sabrina's Ristorante Italiano, Le Bistro and Chart House.
