Subject: H.B. 2769 Relating to Enhanced 911 Services

I am Kenneth G. Silva, Chair of the State Fire Council (SFC) and Fire Chief of the Honolulu Fire Department (HFD). The SFC and the HFD support H.B. 2769, which amends the definition of public safety agency.

This bill proposes to define public safety agency as a functional division of the state or county that has authority to provide fire fighting, law enforcement, ambulance, medical, or other emergency services. This clarification allows us to focus our funding and resources on the state and county public safety answering points that provide emergency services for our community.

The SFC and the HFD urge your committee's support on the passage of H.B. 2769.
