# Re: HB2773HD3 RELATING TO THE WEED AND SEED PROGRAM

### I. OVERVIEW OF PROPOSED LEGISLATION

HB 2773HD3 proposes to establish a Weed and Seed program in the DLIR, through the Office of Community Services (OCS), to maintain the program in areas currently designated for the Weed and Seed program and expand the program into other areas of the state. The bill would also appropriate General Funds for the program.

DLIR opposes creating a new program within the department under OCS. However, the department does support OCS administering a chapter 42F Grant-in-Aid for the program, as they have for a number of years. The department suggests that any appropriation in the proposal should also cover the administrative costs. Lastly, the DLIR's support of the proposal is contingent upon its passage not displacing the funding priorities of the administration.

# **II. CURRENT LAW**

Currently, OCS administers the Weed and Seed Program as a Grant-in-Aid pursuant to chapter 42F. A permanent program does not exist.

# III. COMMENTS ON THE HOUSE BILL

DLIR supports and shares OCS's concerns with the measure as currently drafted. The reduction of crime and drug use is both outside the scope of OCS and the prevention of crime is outside the mission of DLIR. The measure as currently worded would task OCS with providing direct services, which would require significantly more resources including staff. The department notes that under HRS Chapter 371K, OCS's mission is to contract out services to other entities to provide services and then provide administrative support and oversight.

In addition, the proposal establishes a new program within DLIR to maintain and expand the current program, which the department opposes. OCS has administered a chapter 42F Grant-in-Aid for the Weed and Seed Program for a number of years. The department notes that the budget for OCS at both the state and federal levels has decreased over the last few budget cycles.

In sum, the department is supportive of OCS administering a Grant-In-Aid for the Weed and Seed program as long as the proposal's passage does not displace the funding priorities of the administration.

# Testimony for House Bill 2773, HD3-Relating to the Weed and Seed Program

# I. OVERVIEW OF PROPOSED LEGISLATION

The current proposal, HB 2773, HD1, would create a Weed and Seed program in the Department of Labor and Industrial Relations (DLIR), through the Office of Community Services, as well as create a new requirement for a report to the Legislature to be submitted by the Department. The bill would also appropriate an unspecified amount of General Funds for the program. Additionally, the bill would provide a blank 42F grant to the YMCA of Honolulu for the program.

The Office of Community Services supports this legislation, with a few comments.

# II. CURRENT LAW

Currently, OCS administers the Weed and Seed Program as a Grant-in-Aid pursuant to Chapter 42F. A permanent program does not exist.

### III. COMMENTS ON HOUSE BILL

Given our previous testimony we will comment on the legislation in its current form. In general, OCS is supportive of the program. As we have iterated before, the Weed and Seed program is a true community-building and empowerment program, allowing communities to take charge of their neighborhoods through collective strength and shared ideals.

We are confident that as a State agency, we have the knowledge and expertise to run any program within our mandate the Legislature seeks to fund or to create. However, the current funding mechanisms cannot continue to coexist moving forward. The co-mingling of a grant and general fund procurement would cause confusion and interfere with our ability to run either version of the program.

As stated in previous testimonies by OCS, we would also like to ensure whatever program is funded, if any, contains a provision for the recovery of our administrative costs, and does not interfere with the priorities of the Executive Supplemental Budget.

# RE: HB2773, HD3 RELATING TO THE WEED AND SEED PROGRAM

My name is Maile Kanemaru, Director of Honolulu Weed and Seed, and now retired from the YMCA of Honolulu. I have been the Director of Weed and Seed for the past 12 years.

I am in strong support of HB2773, HD3.

Weed and Seed is a program sponsored by the United States Attorney's Office for the District of Hawaii, in partnership with the YMCA of Honolulu.

Weed and Seed on a National level was a victim of budget cuts when the Department of Justice decided to cut grant programs. Weed and Seed was one the oldest, being around since the Bush I administration. In Hawaii, we received the permission from the DOJ to continue with the program, including using the name and logo, recognizing that W&S in Hawaii is robust and supported by the community.

Since it is no longer a program from the Dept of Justice, there are no restrictions, such as three sites per county. Therefore, we have received numerous requests from communities across the state asking for assistance. They would like to learn the strategies that Weed and Seed has demonstrated to be successful.

The collaborative effort involving law enforcement, residents, non-profit organizations, community groups and private businesses has helped to reduce crime and improve the quality of life for the designated neighborhoods. It is a program doing substantial good in our communities to improve the quality of life.

The State has benefited greatly from the Weed and Seed Program and that is based on the two-pronged approach of "weeding out" criminal activity and introducing "seeding" activities and programs ensuring long-term positive changes and a better quality of life for stakeholders.

Since there are no longer funds available for Weed and Seed from the Department of Justice, we are depending on local government and private donations to continue the program. The current funds end in October of 2012.

We have been asked by the Administration to focus on Mayor Wright Homes to address some of the recent incidents which jeopardizes safe and decent housing for our families in Public Housing. We will need the support of the Legislature to do this.

The purpose of the Act is to appropriate funds for a grant-in-aid to the Young Men's Christian Association (YMCA) to support the operations of the Weed and Seed Program through the Department of Labor, Office of Community Services.

The YMCA of Honolulu has been the fiscal agent and employer of the Weed and Seed staff for twelve years.

After speaking with staff from the Department of Labor, Office of Community Services, as well as staff from the Attorney General's office, the alternative grant-in-aid, is preferable to establishing Weed and Seed as a program within the Dept of Labor.

The Office of Community Service has in the past, been a Program Manager of funds for Weed and Seed. Most of the residents served are from low to moderate income households and many are from immigrant families.
