Re: H.B. No. 2773 Relating to the Weed and Seed Program

I. OVERVIEW OF PROPOSED LEGISLATION

HB2773 creates a Weed and Seed program in the Office of Community Services (OCS), which is administratively attached to the Department of Labor and Industrial Relations (DLIR). The measure appropriates funds and requires a report to the legislature from the department.

We support this bill provided that its passage does not displace the funding priorities of the administration.

III. COMMENTS ON THE HOUSE BILL

DLIR supports and shares OCS's concerns with the measure as currently drafted. The reduction of crime and drug use is both outside the scope of OCS and the prevention of crime is outside the mission of DLIR. The measure as currently worded would task OCS with providing direct services, which would require significantly more resources including staff. The department notes that under HRS Chapter 371K, OCS's mission is to contract out services to other entities to provide services and then provide administrative support and oversight.

The department defers to the Department of Human Resources Development in regards to the potential roadblocks identified by OCS regarding program expenses associated with personnel issues.

Testimony for House Bill 2773-Relating to the Weed and Seed Program

POSITION: Support w/Comments

I. OVERVIEW OF PROPOSED LEGISLATION

The current proposal, HB 2773, would create a Weed and Seed program in the Department of Labor and Industrial Relations (DLIR) as well as create a new requirement for a report to the Legislature to be submitted by the Department. The bill would also appropriate funds for the measure.

II. CURRENT LAW

Currently, OCS administers the Weed and Seed Program as a Grant-in-Aid pursuant to Chapter 42F.

III. HOUSE BILL

In general, OCS is supportive of the program. During the administration of this grant, it is evident the agencies involved work hard to create community coordination. The agencies also provide intangible support to persons dedicated to improving their own lives and the lives of their fellow community members.

As the prevention of crime is outside the mission of DLIR, OCS would most likely be tasked with the implementation of this program. With that in mind, we have the following concerns:

1) The three main functions of the program, as stated in the bill, are to “Create, initiate, implement, and support responsible community-based activities, projects, and services that help reduce crime and drug use in neighborhoods; Engage members of the community to encourage the development and maintenance of economic and social well-being; and Teach and model collaborative efforts that focus on sustainable results.” We note that OCS is not a direct service agency and we believe it was never intended to take on such a role. Our mission, under HRS Chapter 371K, is to contract out for non-profit and other agencies to provide such services, while we provide administrative support, planning, and administrative oversight over the service providers for these programs. As currently worded, this bill may task OCS with providing direct services, which would require much more staff and resources. We would prefer language which allows us to contract out for such services.

2) Some program expenses in the past were for police officers, on overtime, that assist and train persons in the activities of community policing. We would like an opportunity to confer with the State of Hawaii Organization of Police Officers, the Counties, and the Department of Human Resources Development in order to ensure there are no particular roadblocks to funding such activities with State funds.

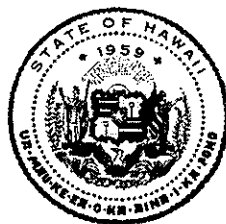
3) As currently worded, it seems OCS would be the agency to coordinate and run the “activities, projects, and services.” OCS is thoroughly supportive of the collaborative model and would appreciate an opportunity to be such a coordinating agency. However, our mandate requires there be a low-income or disadvantaged element to each population we serve. Currently, the reduction of crime and drug use is outside of our scope.

4) As stated in previous conversations regarding the use of General funds for programmatic purposes, any such program funded by the General Fund is subject to the Procurement Code. In any procurement, OCS cannot guarantee the same service areas and providers who in the past have administered this program will be selected to provide these services again.

5) Finally, this bill may have a fiscal impact. OCS will defer to the Governor’s Office and the Department of Labor and Industrial Relations with regard to the overall funding priorities of the proposed budget.
