Chair Herkes and committee members:

My name is Alex Kagawa and I am in support of HB2799 HD1.

This bill will help our condominium unit owners who may want to install an electric vehicle charging system.

For the purposes of resident parking, our condominium does not have assigned parking, instead, we use a parking pool method which is first come, first served. This system has been in place since the project opened and is documented in our declaration and house rules.

Currently, as the law is written, charging systems could be scattered throughout the parking garage with wiring conduits running through multiple floors and spanning the entire length of the structure. Secondly, if a charging system were placed on the uncovered top level of the parking structure, it would be exposed to the elements which would cause the system to age faster than if it were placed in a covered area. Lastly, if a charging system were installed in a regular sized stall instead of a compact size stall, this would be a waste and misuse of a regular sized stall for an electric vehicle that is normally compact in size.

Last year I contacted DBEDT strategic industries and DCCA Real Estate Branch for assistance and clarification on HRS196-7.5, both departments responded that I should consult an attorney.

To satisfy the objectives to promote alternative fuels and to preserve our parking pool system, I support HB2799 HD1's language that allows our association the authority to select the best location for a charging system.

Finally, I would like to ask for your committee's assistance in making the definition of electric vehicle charging system in HRS 196-7.5 (e) consistent with HRS 291-71. This can be achieved by including in HRS 196-7.5(e) that such systems shall meet recognized standards, including SAE J1772 of the Society of Automotive Engineers. This addition together with SB2747 SD1 section 2 (b) will make both HRS sections consistent in the definition of electric vehicle charging systems.

For these reason, I urge the committee to pass HB2799 HD1 with the amendments to the definition as mentioned above.
