Chair Ige, Vice Chair Kidani, and Members of the Committee:

I am Brian Miyamoto, Chief Operating Officer and Government Affairs Liaison for the Hawaii Farm Bureau Federation (HFBF). Organized since 1948, the HFBF is comprised of 1,800 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interest of our diverse agricultural community.

HFBF supports the intent of HB 280, HD1, SD1, which proposes to remove the requirement that all Hawaii-grown green coffee beans be inspected and certified by the Hawaii Department of Agriculture (HDOA) unless otherwise specified by rules of the HDOA. It also removes the requirement that no Hawaii-grown green coffee beans shall be shipped outside the area of their geographic origin unless they have been inspected by the HDOA.

State budgetary cutbacks in recent years have hindered HDOA's ability to effectively execute the coffee certification program. This has led to long delays, hurting customer relations and crimping cash flows for growers and processors. HFBF supports this measure provided that STIFF, ENFORCEABLE PENALTIES IN THE LAW will punish and deter the act of counterfeiting Hawaiian grown coffee.

It is expected that minimum grade standards will be regulated by the free marketplace. The repeal of mandatory inspection and certification for origin leaves a gap that may lead to coffee counterfeiting. We need to give law enforcement the tools they need to protect Hawaii's valuable coffee industry. HFBF will continue to work with HDOA, industry and law enforcement to ensure that amendments are made to this measure making counterfeiting of coffee a criminal offense.

The Senate Committee on Agriculture determined in its report on this measure that: "grading and certification standards for Hawaii-grown green coffee are important for preserving the integrity of Hawaii's coffee industry and protecting consumers", but that HDOA should no longer be mandated to "inspect and certify [green coffee] for grade and origin."

If inspection and certification of grade and origin are important for preserving the value of integrity and the policy of consumer protection it passes understanding to think that inspection and certification should not be mandatory—as they have for the last 15 years. Enactment of this legislation is a statement by the Hawaii Legislature that in fact neither integrity nor consumer protection are really that important.

My name is Derek Lanter and I am the manager of Waialua Estate Coffee and Cacao on the North Shore of Oahu. I am writing in support of HB 280, a bill that we have worked hard to get passed. This bill removes the statute requiring mandatory state certification of coffee making it a voluntary option. It would also allow for self certification while still providing for integrity of origin and quality.

There have been many problems with the existing mandatory certification process including: delays in processing; a lack of qualified inspectors sufficient to handle the volumes of coffee for grading; training and standards that are not up date with changing market conditions and processing techniques; subjective interpretation of cupping standards that result in downgrades; all of which result in obstacles to commerce between the buyer and seller that can jeopardize business transactions.

Unfortunately the lack of funding in the state has led to diminished inspector numbers and the professional development to keep up with industry changes and the broad based quality assessment training necessary for this specialty crop. Inspectors need training and highly developed sensory skills to evaluate cup quality and provide objective evaluation of the regional differences in coffee variety, processing techniques and market tastes that drive production and sales. Although grading and certification are meant to provides a service for quality assurance, it has not kept pace with the industry changes and market demands and has instead become a bottleneck in commerce and the source of a great dissatisfaction for producers and buyers alike.

HB 280 would alleviate this bottleneck allowing for qualified self certification or voluntary certification of grade where needed. This change will greatly facilitate the flow of product at critical seasons and allow farmers to sell their coffee without undue delay. It is understood that the origin of the coffee with still be verified to prevent counterfeit but that official grading will be a voluntary option.

I am in favor of keeping the grading system in place on a voluntary basis for those clients that wish to have such a service performed.

As written the bill will, in my opinion, strengthen the origin controls of the coffee and those requirements I/we support. As a roaster, I would caution the committee, to ensure that the language in this bill be clear to encompass green unroasted coffee including parchment and cherry but exclude roasted coffee since the farm origin is not and cannot always be known to the roaster.

As a roaster, I want to know that when I buy origin coffee from the processor I am able to buy and roast such coffee with confidence that the coffee is from the origin as labeled without being at risk of a potential felony.

I strongly support HB 280 with recommended amendments, which eliminates Mandatory Certification of Hawaii coffee for quality grading while strengthening the requirement for Mandatory Origin documentation. Under HB 280 SD1, certification of the Hawaiian coffee grading will now be voluntary instead of mandatory but documentation of Hawaiian coffee origin will now become mandatory which will do a better job of preventing the counterfeiting of Hawaiian coffee. For those growers who find it desireable for their business model to have State Certification of Grade, it will still be available but on a voluntary basis. Under this Bill, counterfeiting of Hawaiian coffee will become a Class C Felony with prosecution of violations handled by the Prosecutors office. In the past 2 years, certification of coffee has become cumbersome and problematic. Budget cuts to the Department of Agriculture have led to furloughs and employee cuts. There are not enough certification agents to get the job done. The Hawaii Department of Agriculture supports HB 280 as does the Hawaii Coffee Association, the Kona Coffee Council, the Hawaii Coffee Growers Association, the Maui Coffee Association, the Hawaii Farm Burea and the Ka'u Farm Bureau. Overall, the Hawaiian coffee industry is clearly behind this Bill.
