Testimony of WILLIAM J. AILA, JR. Chairperson

In consideration of HOUSE BILL 2820 RELATING TO HAWAIIAN FISHPONDS

House Bill 2820 proposes to amend Chapter 183B, Hawaii Revised Statutes (HRS), to require the Department of Land and Natural Resources (DLNR) to establish the east Honolulu fishpond heritage area. The purposes of the area would be to preserve cultural and historical sites; preserve and protect native Hawaii fish, plants and endangered birds in the area; protect spring water sources; provide a site for future public interpretation of the fishponds' cultural, biological and historical areas; and provide for the reconstruction, rehabilitation and stocking of fishponds subject to Section 171-28, HRS. DLNR opposes this bill as written.

DLNR respectfully suggests the following changes to the language of the bill to preserve existing conditions. As such, DLNR asks that subsection (a)(1) be amended as follows: "Preserve existing cultural and historical sites, including traditional rock walls, fishpond gates, and auwai;"; subsection (a)(2) be amended as follows: "Preserve and protect existing native Hawaiian fish, plants, and endangered birds that presently inhabit the area;"; and subsection (a)(3) be amended as follows "Protect Preserve existing spring water sources, on the surface and underground, from harmful alterations and development;". DLNR also recommends that subsections (a)(4) and (a)(5) be deleted from the bill.

Finally, the properties identified in the bill are owned in fee by the State Department of Transportation (DOT), not DLNR. The properties were acquired with federal funds in condemnation proceedings pursuant to the Kalanianaole Highway widening project. In the event any of the properties are proposed to be transferred by DOT to DLNR at gratis¹, DLNR would still need to conduct the necessary due diligence prior to a recommendation and final decision by the Board of Land and Natural Resources on any acquisition.
