HOUSE BILL NO. 2832 RELATING TO DROUGHT MITIGATION

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2832. The purpose of this bill is to appropriate funds to the counties for drought mitigation purposes. It also requires the counties to report to the Legislature on the status of drought mitigation projects. The department supports the intent of this bill provided it does not impact the initiatives set forth in our executive biennium budget.

The effects of drought on agriculture can be devastating. With the possibility of drought lasting for years, crop yields can fall dramatically and farms can close. Approximately eight years ago, the Commission on Water Resource Management assisted in the creation of drought committees in each county. The committees then came up with prioritized, potential projects, including reservoir construction, to implement in order to mitigate the effects of drought. This request represents recognition of the importance and need for these projects.

In Consideration of HOUSE BILL 2832 RELATING TO DROUGHT MITIGATION

The purpose of House Bill 2832 is to provide a grant-in-aid of an unspecified amount of general revenues for agricultural drought mitigation measures and projects in each county of the State for fiscal year 2012-2013. The Department of Land and Natural Resources (Department) appreciates the intent of this measure, however is not able to support it at this time because funding for these projects would negatively impact the Executive Supplemental Budget request.

The Department recognizes the need to mitigate the effects of drought and this need is acknowledged in the Hawaii Drought Plan. Droughts have severely affected Hawaii in the past, and as part of a natural climate cycle, droughts will impact the State in the future. In addition to agriculture and livestock industries, drought-induced impacts will also affect other sectors of the community, such as water supply, business, the environment, and public health and safety.

The Department concurs with the importance of drought planning and the effective implementation of mitigation measures and strategies. The Hawaii Drought Plan and the County Drought Mitigation Strategies identify and recommend implementation of drought mitigation actions, subject to available funding. These Drought Mitigation Strategies were developed in consultation with key stakeholders who participated as members of the respective local County Drought Committees to identify and prioritize projects to help reduce the impacts of drought in their communities.


Drought, in its most severe form decimates crops and livestock, erodes the landscape, damages terrestrial and aquatic wildlife habitat, contributes to widespread wildfire, and results in hundreds of millions of dollars in damage. Drought can lead to tough decisions regarding the allocation water, stringent water use limitations, problems in ensuring safe drinking water and adequate water supplies for fire fighting efforts. Based on past experience, the most important lesson leamed was that the best time to reduce the impacts of drought is before they occur. In 2004 Maui County completed a plan that advocates a proactive drought management approach, "The County of Maui Drought Mitigation Strategy."

Sufficient funding is necessary to address the many challenges posed by drought. <u>The Maui</u> <u>County Department of Water Supply supports H.B. 2832 to appropriate funds to the Counties for</u> <u>drought mitigation purposes.</u>

HB 2832 RELATING TO DROUGHT MITIGATION

Chairman Tsuji, Vice Chair Hashem and Members of the Committee:

My name is Alan Gottlieb, and I am a rancher and the Government Affairs Chair for the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council strongly supports HB 2832.

A report from the University of Hawaii predicts reduced trade winds and increased storm events. This means Hawaii must reassess its water resources and prepare to face extended droughts interspersed with severe storm events.

Changing weather conditions make water one of the most important risks facing farmers and ranchers. As Hawaii moves towards increased self sufficiency and sustainability, efforts must be taken to reduce risks borne by farms and ranches. When borne alone, farm and ranch viability is reduced to points in which farmers and ranchers must make the hard decision of whether their enterprise can support their families or survive as a business. Having sound drought mitigation plans are essential if we are going to survive. We cannot have these plans and infrastructure in place without adequate funding. Please fund this bill.
